Tri-State truck and told them they could not travel Main Street. The solicitor should check into this matter as I am not sure the borough has the right to regulate traffic on a state road. Mr. Kilker said he would write a memo on this matter.

At this time C. Marquardt read a note from J. Kilker. The letter was agreed to but he could not attend to it due to personal circumstances. Mr. Kilker believes that Mark Kessler is still on the force. Vote called for again. Opposed M.B. Dougherty and R. Krick. Motion carried.

Treasurer's report: Motion to accept the report as read made by J. Haluska, seconded by J. Yackera. Vote. All. Motion carried.

Tax Collector's report: Motion to accept report as submitted and to pay the tax collector made by J. Yackera, seconded by J. Haluska. Vote. All. Motion carried.

Mayor's report: Read by J. Kelly.. Motion to accept as read made by J. Yackera, seconded by J. Tinari. Vote. All. Motion carried.

M.B. Dougherty noted that in the process of doing some research on the internet she came across a report that the Girardville Police Pension fund had to pay back money to the Auditor General's office. This occurred in August 1998. Last summer the ordinance was changed due to recommendations of the Auditor's office as a result of audit findings but to her recollection this matter was never brought up before Council for discussion. R. Krick said that someone should look into this. C. Marquardt instructed J. Tinari to get a copy of this press release and investigate.

R. Krick asked how Council wants formal complaints against police officers? Should it be in writing or how? J. Yackera said that Council could hold an executive session to discuss any personnel complaints or it could be submitted in writing. C. Marquardt said that Council would go into Executive session before the end of this meeting.

Meeting opened with the Pledge of Allegiance led by Council President C. Marquardt.

ROLL CALL

PUBLIC COMMENT

Mr. Thomas Flannery said that upon purchasing a building permit he was told that anyone hired to do work in the borough needed to have liability insurance. He asked C. Marquardt where his liability insurance policy was? C. Marquardt said that any contractor who has employees must have liability insurance. C. Marquardt said he has no one working for him and has no need to carry insurance. T. Flannery also complained about drinking and drug dealing across from his home. Nothing is being done about these problems. He suggested that council members get in their cars and see what is going on around town. J. Yackera asked if Mr. Flannery did this and suggested he make phone calls to the police. He asked Mayor Kelly if he was familiar with the police tenure act. J. Yackera informed T. Flannery that these matters should be discussed at a Police committee meeting. Upon being asked when that would be, J. Yackera said one could be scheduled at T. Flannery's convenience. Flannery noted that his attorney would be present as well.

Lack of response to his letter of May 1999 was again questioned. He said he understood that J. Yackera and J. Tinari did the investigation and there were no findings. He questioned both council members expertise to investigate such a matter. The complaint made to J. Yackera concerned Flannery's being arrested by Officer Kessler. J. Yackera answered that he listened to both stories but is not a judge. Flannery went on to note allegations of fabrication of charges. Accusations of perjury and falsification were levied.

J. Yackera noted that this would be a matter for law enforcement, perhaps the State Police or the Attorney General's office. This was directed to me as Chairman of the police committee and I am admittedly not qualified to investigate this. Mr. Kilker stated that the letter did not request an answer. T. Flannery noted that Mayor Kelly guaranteed a written response. J. Kilker said that he would contact Attorney E. Brennan tomorrow and get something in writing.

E. Ketusky asked how long does it take to open a storm drain? It has been blocked for seven (7) years. V. Ambrose noted that the drain in question was opened two (2) months ago.

M. Ritro asked if there had been any progress on the his complaint concerning the cars? It was reported by Ofcr. M. Kessler that the vehicles in question are tarped. He did not enter the property. Mayor Kelly informed M. Ritro that this matter has been turned over to the health officer.

- J. Charetti asked if there has been any action concerning the property on West Main Street? Mayor Kelly said that citations had been sent out and the matter will be before the magistrate. A hearing date has to be set. Ofcr. Kessler noted that hearings are usually arranged within ten (10) days. J. Charetti went on to note that there are a lot of people not taking care of their properties. Why aren't ordinances created to enforce these things? J. Kilker noted that state law will now require all municipalities to enforce the BOCA codes. Ordinances will have to be passed.
- J. Salukas asked why the fire siren does not blow at night for fires? J. Yackera informed him that Schuylkill County control blows the siren for all structure fires. The only time the siren is not blown is for brush fires and automobile accidents or if there is mechanical difficulty with the siren itself. J. Salukas said he was told that all the firefighters have pagers and the siren will not be blown for house fires. J. Yackera said that he would contact Frank Zangari and have a letter written and sent to Mr. Salukas if he wished or he could contact County Control and request information on their siren policy. This information if readily available at anyone's request.

Census representative, Mr. Bill Thomas, was given the floor at this time. Mr. Thomas addressed council and the residents present concerning jobs available working for the Census Bureau. Information will be available in the office and locally. The enumerator's positions are paying between \$11.00 and \$12.50 per hour and \$0.31 per mile. Mr. Kilker asked if the jobs are full time. Mr. Thomas said that ideally they are but if someone has 10-20 hour per week available they are willing to hire on that basis. C. Marquardt thanked him for his time.
