PUBLIC COMMENT

Mrs. Subick asked what if anything Council planned to do about the building on the corner of Ogden and William Street? There are ordinances in place to condemn this building. Repeated calls to the owner result in a day or two worth of work and then nothing for months. Mayor Kelly noted that the owner has been cited numerous times. Solicitor J. Mr. Ritro asked if there is an ordinance regarding putting chairs and buckets out to save parking spaces? It is ridiculous, you cannot find a parking space. People are gone all day and have cans or chairs out. Mr. Kilker told him that legally anyone could remove whatever was blocking the space and park. M.B. Dougherty noted that Ashland had their police department remove the object but they started running out of room. J. Kilker said that they must have had an ordinance to that effect. COMMITTEE REPORTS

Streets: R. Krick announced a committee meeting for, Wednesday, February 16, at 6:30 PM. There is concern about private residents or contractors clearing snow from parking

spaces and piling it on corners. This creates dangerous situations for drivers trying to pull out into the intersections. The meeting may yield some type of guidelines.

R. Krick noted that he had a list of the handicapped parking spaces in hand and one renewal check. He requested letters be sent reminding holders of spaces that the annual renewal fee is due.

Police: M.B. Dougherty noted that after the committee meeting of, January 24, the following things need to be acted upon. A log of hearings should be kept allowing review. Daily reports must be filled out and checked for accuracy. Access to the evidence locker must be kept to a minimum. On calls classified as "information received" the officers must be certain to get both sides of the story. Officer Kufro was given use of the Borough's gun as he does not own one. All officers should read and sign copies of the various policies. A request for the purchase of a cell phone was made by Officer Livergood. M.B. Dougherty said that at this time she sees no need and suggests council deny the request. R. Krick said he agrees with this position. Officer Livergood brought to the committee's attention the possibility of purchasing guns through the Federal Surplus program. These are FBI issued 9 mm that are being made available to law enforcement agencies at \$25.00 each. The committee discussed purchasing weapons to be issued to our police officers. These weapons are to be used only when on duty and to be secured in lockers when not in use. Motion to make a request to Federal Surplus to purchase four (4), nine millimeter (9mm) pistols at \$25.00 each made by M.B. Dougherty, seconded R. Krick. Question? C. Marquardt asked if council wanted to discuss a policy concerning the weapons? R. Krick noted that there is time, if the guns are purchased to have a policy reviewed and in place. M.B. Dougherty noted the Mayor and Officer Livergood need to be made aware that the agreement is to purchase four (4) weapons not the five (5) requested. Vote. All. Motion carried.

M.B. Dougherty asked if council wanted to consider a decision of the requested sale of the borough's 357? R. Krick suggested waiting until we see if the proposed weapons purchase is finalized.

How soon is the new system going to be operable? The contract date is October, 2000.

Will the authority wait for hook up fees? R. Krick noted that the Authority members think they can wait but are checking into that matter.

Questions about dirt and dust from the project were raised and referred to the GAMA monthly meeting.

M.B. Dougherty noted that if and when funds are approved notices would be put out so that everyone was aware.

PUBLIC COMMENT

Mrs. Subick asked why the building being torn down does not have a permit issued to date? If he doesn't need a permit why does anyone else in town need one? J. Yackera said he spoke with Theresa Niedzwiecki and she informed him that the permit fees are being tripled in way of a fine and that Mr. Scott is aware of this matter. It has been a simple case of schedules not allowing her to see him. J. Yackera further explained that the only other alternative is to shut down the job and take him to the magistrate for non-payment and no one wants the job shut down for any reason. As for his not working on the building at the present time that is a matter for the Magistrate not the Borough. C. Marquardt said he will have the matter of the unpaid permit passed on to the police department.

Mr. Humes asked what progress is being made with the Bernotas property. He was informed that the demolition projects will be discussed later in the meeting.

Mr. Charetti asked if anything could be done concerning the dust and dirt problem on Oak Street. Vehicles are speeding up and down making the problems worse. Mayor Kelly said the only answer is to approach the contractor. R. Krick noted that the contractor is responsible for the ditch but the borough cannot intervene in the construction process. The streets will be paved when the contractor is ready to begin paving.

Mr. D. Kelly asked again if something could be done about the kids hanging out on the corner of Main and Second Street. He called at 11:30 PM on an evening that an officer was scheduled until 12:00 AM and was told that there was no officer n duty at the time. Mayor Kelly said he would check the schedule. The police only chase the kids if a complaint is made and they are back in a matter of minutes. Mr. T. Flannery noted that he has seen Officer Kessler standing and talking with the kids and not chasing them from the corners.

Underage drinking and damage to vehicles parked in the area have been the norm. C. Marquardt noted that letters have been sent to the Railroad and this additional matter would be addressed. Mr. T. Flannery noted there is lack of enforcement. Four wheelers traveling up and down Main Street are friends of the officers. Selective enforcement.

Mr. M. Yesalavage asked if there would be a police report tonight and he was told yes. He asked if Marvin Livergood was in attendance and was told not at this time.

He noted that the dog owners cannot be approached to solve this problem. At this point Mrs. Prep suggested that M. Yesalavge tell Council about the M 80's he had set off and the number of times he has been before the magistrate on charges. These are highly trained dogs and there have been threats made to kill the dogs. These dogs are family pets and have never bitten anyone. C. Marquardt noted that according to the Mayor this entire matter has been investigated and any and all questions need to be addressed to Officer Livergood.

Mark Kessler asked to address questions to Council and noted he was here as a private citizen. His questions were addressed primarily to M.B. Dougherty as head of the police committee. M.B. Dougherty asked for the questions in writing so as to be better able to address the concerns. M. Kessler told her he only had notes that he had written for himself.

Additional note: I requested a copy of the questions and statistics quoted from M. Kessler immediately following the meeting. He agreed to submit this but to date no such copy has been received.

C. Marquardt suggested that a better way would be to have the concerns addressed at a committee meeting or work session. M. Kessler insisted he had the right to ask any questions as a private citizen and have them answered at a Council meeting. M.B. Dougherty agreed to address his questions.

What plan does Council have to address the crime situation in the borough? Considering the last several meeting what is going on in our current police needs to be addressed. Not very happy with services as they are now.

What type of training have you had in supervision and leadership of a police department and what improvements have you made since becoming president of the police committee? As far as supervision of the police department it is necessary to make it clear that the mayor is in charge of the police but I do have supervisory experience in past jobs. I have not had any specific training for police departments.

M.B. Dougherty noted that it is unfortunate the you as an officer come to council asking these questions. I don't think the police department is doing a good job and if it were up to me we would start from scratch. I am only one vote and can suggest anything in the way of improvements but without the votes to make changes.

Is there a future for the police department and if so what can be done to improve it? I

would love to see regionalization because we are not effectively serving residents. The two biggest problems facing this borough are code enforcement and police protection. We do not have a code enforcement officer because of the costs involved and are trying to address this matter through the COG. It would be much more effectively to do it jointly and do it right. The same would apply to the police department.

M. Kessler said he would like to see a full time police department with 24 hour a day 7 day a week protection. M.B. Dougherty answered that would be the ideal and would be great if we could afford it. Recently there have been complaints about you personally not responding to calls from residents and sending them to the State Police for matters of Borough ordinances.

At several points during this portion of the meeting there was shouting and accusations between residents on the floor, Officer Kessler and members of Council. At one point immediately before the meeting was adjourned Councilor J. Yackera walked out of chambers saying it was totally out of control.

At this point Mr. T. Flannery noted that this situation is ironic and he'd suggest that M. Kessler get himself a defense attorney.

M.B. Dougherty agreed that we have done a lousy job with our police department and need to improve service. No one seems to want to look at what is going on in this police department. R. Krick noted that every member on Council knows what is going on even if they do not want to admit it.

Council President C. Marquardt called for a motion to adjourn. Motion to adjourn made by M.B. Dougherty, seconded R. Krick. Vote. All.

PUBLIC COMMENT

- E. Burns asked if there is any law stipulating that people be off the basketball courts at a specific time. Area residents have complained about the noise at late hours.

 C. Marquardt said that the parks and basketball courts will be posted closed at 9:00 PM. Residents complained that we need police protection at night not in the middle of the afternoons. Arrests must be made not just warnings issued. Complaints about police protection in general were brought to Council's attention. Mr. Kilker arrived, 7:20 PM.
- T. Flannery informed council that the borough is being investigated and facing a federal lawsuit and it seems another is in the works. At this point Mr. Kilker suggested that council consider going into and executive session and decide something at that time.
- J. Clayton asked if there would be answers tonight? M.B. Dougherty said this is something that will take some time. R. Krick noted that every time council rushes to hire it backfires and we need to take our time in reaching a decision. J. Clayton asked if citizens would have anything to say about who is hired or how changes are made in the police department. M.B. Dougherty said that it is possible to form a citizen's committee. T. Flannery asked about using Civil Service and was told you need a minimum of 3 full-time officers to be considered for Civil Service.
- A. Engle asked if anything was being done about the property on the corner of William and Ogden Streets? R. Krick told him that this matter is in court and now that DEP is

involved it becomes very complicated. J. Kilker noted that the suit is ready to be filed for preliminary injunction to clear the streets and give 30 days to clean the property and fence. Complaints were again lodged that residents must get permits to improve their property and yet these places are allowed to just sit and get worse and worse.

Mr. Kilker added that with the County Demolition program the borough is now in a position to tell property owners they have to take care of problem properties.

G. Brennan asked about the tall grass on E. Mahanoy Avenue. C. Marquardt told her that citations will be issued. The location of the current owner has now been determined and he will receive the citations. M.B. Dougherty asked if we can get on the property. J. Kilker said if you post it with five (5) days notice you can enter the property and make it punitive. M.B. Dougherty said post it tonight.

Questions about the possible usage of the Matulatis property were raised by neighbors. C. Marquardt informed them that we are under County Zoning and any usage must be approved through that office. The Council has no way to make a determination but all permits must be acquired first.

Questions about the status with the railroad properties were asked. The PUC complaint forms are available for residents concerning the cribbing on William Street. The borough has submitted a complaint on this matter. As for the wall, C. Marquardt noted that project is supposed to be slated for this year but we have heard nothing from their office. Letters and phone calls about these matters have gone unanswered.

Mrs. Subick asked if DEP knows if it was a pocket of gas or tanks that caused the fire on William Street? R. Krick said it was contaminated soil that was on fire. Right now, that section of the sewer project is on hold. Cost and responsibility for clean up will be determined down the road.

K. Malloy asked about the building where the "raves" are supposed to be held on West Main Street. There was a flurry of activity and now seems to be no action. J. Kilker told her that the owner will have to get all the required state and local occupancy permits before he will be allowed to hold any activities in that building. The area is zoned commercial and as long as he meets County zoning requirements the borough has no control.

E. Burns complained about the state of the streets stating the contractor is not fulfilling his obligations. He told residents of the construction conference scheduled for, Monday, July 17th at 9:00 AM. He suggested residents plan to attend and lodge their complaints in front of K. Rapose, USDA. On questions of property damage, residents were informed there are forms they must obtain from the Engineer to fill out and file. These forms can be obtained over at the construction trailer from Larry Fertich.

Mr. Kilker noted that the railroad has not responded to the complaints made. R. Krick noted that the PUC regulates railroad crossings and this matter may need to be taken to the RailRoad Board in Washington DC. Mr. J. Barrett noted that he received responses to his complaints. PADOT denies responsibility and it seems so does everyone else. J. Kilker said we could approach both Tamaqua and Mahanoy City about their problems with Reading Blue Mountain. The railroad's response seems to be go to Washington DC.

B. Johnston made a complaint about the old Fedder's property on East Ogden Street. It is a garbage dump. There are four vehicles there along with plaster and lath from the remodeling project they are doing. C. Marquardt said that the fire chief and health officer are looking into this matter. A previously sent letter was answered. Mr. Kilker said that the residents claimed that requests for permits were denied and that they were doing the required work. Mayor Kelly said he believed that the property has already been cited. Further investigation will be done in this matter.

Ira Huntington noted problems with his sewer due to the current sewer project. He claims that the digging is leaving debris, which washes, into the sewer lines and causes back ups into cellars. The streets are bad and nothing is done about it. C. Marquardt noted that when cones and flashers are put out they are stolen do the company has taken to painting the pipes fluorescent orange for safety. Mr. Huntington was told to lodge any complaints with the contractor. R. Krick noted that the old sewer system does have a drainage problem. This line has been flushed and is open. Once the new lines are hooked up, these problems should disappear. As for the street conditions, USDA has no funds for restoration until the completion of the contract. The pipes sticking out of the street are there to reduce water in the ditch line. They are not connected to anything and not contributing to any drainage problems. The water level on B Street is part of the problem. V. Ambrose noted that the existing sewer line is a roller coaster. R. Krick noted that B Street has had back up problems for years. Demolition - Mr. Kilker noted that a list of properties was submitted to the County for consideration in the next round of funding. He asked if he should take similar actions concerning these properties as last time? R. Krick suggested taking similar actions. It at all possible we want to have the owners remedy the situation.

R. Krick noted that last month that permission was granted to the Ambulance Association to do mock vehicle rescue. The wrecked vehicles were supposed to be removed within a day and were not. There is a liability question when we allow damaged vehicles to sit unattended for a week. Motion made that future training would only be allowed it the vehicles are removed within 24 hours by R. Krick, seconded J. Haluska. Question? None. Vote. All. Motion carried.

PUBLIC COMMENT

Mr. Kilker asked to address Council from the floor. He asked if Council would consider doing something about the Strong building. It is a safety hazard. The demolition would cost between \$20,000 - 30,000.00. There is a problem with rodents. He spoke to Frank Zangari who informed him that if there was a fire in the section the entire town would lose power. R. Krick said that removing that building will not solve the problem with that section of houses. Michael Kitsock, a local contractor, questioned if you could be able to take that building out without damaging the adjacent buildings. Also, the County will not do renovations on unoccupied buildings. J. Kilker said he would have someone enter the adjacent buildings, privately, and see if they have their own walls and foundations. He requested that Council continue to look at these properties for possible demolition.

It was suggested that the borough have Mr. Heiser convey his property to the Borough or get a quick claim deed issued by the tax claim bureau.

M.B. Dougherty asked the status of the Kish properties. Mr. Kilker said he got back the certified letter sent out and now has a new address. The notices will be sent out again.

Concerning the Muntone property, Mr. Kilker said he needs to check further into the matter of ownership of the property.

The Pennington property on Ogden Street is being cited every day for the violations.

Mr. Kilker is in contact with the owner of the Pinchot property across from the Ranger's Hose Company. They are looking into conveying the deed to the Borough.

Mr. Kilker noted that he is holding the checks issued for the Ross property. He is getting nowhere in locating her. R. Krick said that if we take the building we accept liability. There is the possibility that there will not be a demolition program next year and then the Borough is stuck with the property. C. Marquardt asked how this could be approached. J. Kilker said Council could subpoena financial records if you have reason to believe that someone else is paying the taxes. The tax claim bureau can tell you that taxes were paid but not who paid.

M.B. Dougherty noted that the next COG meeting is January 24, 2001, at 7:00 PM in Delano Township.

R. Krick noted that in the Pennsylvania Magazine he read that Council can regulate payment for members. He suggested a policy where if the member does not attend either the monthly work session or regular meeting they would not be paid for that month. J. Haluska asked about people who could have trouble finding job coverage for swing shifts. R. Krick said that the policy couldn't get into legal excuses because there would always be an excuse. There are some members who consistently do not show up at any meetings. Motion to adopt policy stating if a Council member does not attend either the monthly work session or regular meeting they will not be paid for that month made by R. Krick, seconded M.B. Dougherty.
