J. Chiaretti questioned the police work hours. He added that comments have been made about not ever seeing the car on patrol. Officer Collins reported that for the last couple of weeks he has been on duty every other night for 6 hours and 8 hours on weekends. Mayor Kelly noted that he instructed the officer not to cruise if the weather or the streets are bad. One circuit around town is done upon coming on duty and then he is available to answer calls as needed.

Northern Schuylkill COG – scheduled meeting notice for 1/22/2003 at 7:00 PM at the Girardville Borough Hall.

M.B. Dougherty noted that a representative from PSAB will be in attendance to discuss their Code Enforcement program. She recommended that anyone who was available attend.

#### **COMMITTEE REPORTS**

**Police:** Mayor Kelly noted that he discussed the possibility of a snow emergency route on Main Street and Mahanoy Avenue with a representative of PADOT. After some discussion of the pros and cons of this matter it is decided to table this until spring when public meetings could be held for input from the residents that would be affected. C. Marquardt suggested the Street Committee review this matter.

**Street:** R. Krick noted that there was a meeting with the engineer concerning the problem at Silver Street. He advised that there is a possibility of a Growing Greener Grant to help with this drainage problem due to the mine water that runs into the storm system. There is also the possibility of using the remaining County Aid funds to help pay for this project. The Mahanoy Creek Watershed Association is willing to participate in this as a joint effort. Motion to authorize the engineer to proceed with whatever is needed to file a Growing Greener Grant Application for Silver and Main Street made by R. Krick, second M.B. Dougherty. Question? None. Vote. All. Motion carried.

Motion to authorize a joint Growing Greener application with the Mahanoy Creek Watershed Association for the purpose of monitoring the flow of mine discharge from the Packer Five borehole. This discharge flows into the borough at the western point. Motion made by R. Krick, second M.B. Dougherty. Question? None. Vote. All. Motion carried.

Motion to send a letter to the Mahanoy Creek Watershed Association in support of their Growing Greener application for funding for a wetlands made by R. Krick, second J. Quinn. Question? None. Vote. All. Motion carried.

R. Krick noted that there are concerns about private residents plowing the streets in front of their homes and having the piles left on corners or in front of other private properties.

This poses a traffic hazard as well as parking difficulties. He asked if there is anything the borough can do about this matter. E. Mika suggested addressing this through the crimes codes. Officer Collins will check to see what would be appropriate to address this for possible citations.

C. Marquardt wanted to address the problem of residents tossing snow back into the streets after they are plowed. He said that this practice is a major safety hazard. Residents are to pile snow on the curb and that citations will be issued.

**Recycling:** C. Marquardt informed residents that the County is a bit behind on picking up the recycling. This is due partly to the weather and also needing to replace a driver. He asked that if the bins are full residents not leave their recycling lying on the ground.

Christmas tree pickup is scheduled for January 13th, 14th & 15th

**School:** R. Krick informed Council that the interior doors have been started but due to the contractor taking a week off there will be another week or so to completion. The railing along the exterior ramp has been installed.

#### **OTHER BUSINESS**

E. Mika asked for permission to commence legal proceedings against the owners of the property located at 12 West Main Street. They were given sixty (60) days prior order to clean up the property. The owner has been contacted but nothing has been done. Motion to allow the solicitor to commence with proceedings to obtain an injunction to clean up the property at 12 West Main Street made by M.B. Dougherty, second J. Quinn. Question? None. Vote. All. Motion carried.

E. Mika requested that Council examine the proposed ordinance for street and sidewalk repairs. This is to regulate excavation done by homeowners and contractors. The matter is of immediate interest as the Sewer Authority has advertised and awarded a contract for replacement of sidewalks on East Mahanoy Avenue. He recommends having standards in place and reviewing the GAMA contract for inconsistencies.

J. Petusky requested permission to order four (4) new mats for the floors in the borough hall building at an approximate cost of \$160.00. The mats are not drying fast enough and it allows for slippery floors with everyone tracking in wet shoes. Motion to purchase the requested mats made by M.B. Dougherty, second J. Quinn. Question? None. Vote. All. Motion carried.

R. Krick reported to Council that he had heard about a problem at the Tamaqua site where river dredging is being dumped. Apparently, due to a problem with signage, two truckloads were dumped in the wrong hole. He went on to add that the Susquehanna Headwaters Association is in support of the spreading of biosolids. There are ongoing meetings so that concerned citizens can learn about this and express their opinions.

#### **FLOOR**

Mr. Joseph Cusati asked Council what is going to be done about the cribbing on William and Lower Railroad Street. He noted that there was information last month saying that the railroad is responsible for the repairs. C. Marquardt informed him that Council is waiting to hear if the railroad filed and appeal of the decision which was their right. If not then it is presumed that the work will begin as soon as weather permits. The railroad is responsible to make the necessary repairs and the borough will be required to maintain proper signage and traffic control.

**Street:** R. Krick reported that the borough is out of road salt. C. Marquardt noted that phone calls to various suppliers looking for another delivery have not been successful.

C. Marquardt reminded residents that it is illegal to throw snow out into the streets. This is especially a problem now due to the lack of salt. He reminds residents that there will be citations issued. Also, it is required that each homeowner clear a 24" path on their property within 24 - 48 hours of a snow storm. Again, citations will be issued for noncompliance.

**Recreation:** R. Krick reported that we are waiting on deeds for the parcels behind the school and church. E. Mika noted that the Diocese is working on deeds conveying the properties. When the offer is made the borough will need to decide if they are going to accept. There will be transfer charges payment of which will be required. Girard Estate is unwilling to enter into any long term leases and this takes the C Street Park off the list as a possible location for some of the play equipment. DCNR requires 25 year leases minimum to place equipment paid for through the grant program.

J. Chiaretti noted he was approached about the possible purchase of a portion of the former West End Park. A neighbor wants to put up a garage. R. Krick questioned the borough's ability to sell any of the property due to the liability. DEP's recommendation has been to cap it, plant grass and trees and fence the area. Any digging of any kind could result in contamination.

Sludge ordinance – Solicitor E. Mika noted that it is an excellent ordinance and if the Council is interested in adopting it there will need to be some minor changes. He recommended a committee review this and that a decision be made next month. The committee to review the ordinance will consist of M.B. Dougherty, R. Krick and J. Chiaretti. This matter is tabled pending the review. Copies of the ordinance are to be distributed to each member of Council.

Property Tax billing – J. Chiaretti asked that the matter of the borough's receiving and having to pay property taxes be discussed. He suggested that there be a policy in place to deal with these matters in a timely fashion. E. Mika explained that the State law requires municipalities to pay property taxes unless it can be shown that the property is used for public purposes. If you want a property to be exempt you must file an exemption and show public use. The deadline for filing an exemption for 2003 is passed. It is his opinion that the Borough has to pay the property taxes. M.B. Dougherty objected to paying this portion of the taxes as they are borough taxes. She noted we will be paying the tax collector who then turns the money back over to the borough less her 5% commission. She and everyone else on Council feel this is ridiculous. Both E. Mika and J. Chiaretti spoke with the Assessor's office and came away with the same answers. The taxes must be paid. It was suggested that this may be a matter for the COG as Girardville cannot be the only municipality in this position.

J. Chiaretti also noted that there is a problem with the Osborne properties on Richard Street. The Court House shows they own two properties and the borough owns the third. His understanding is that the Osborne's own all three properties. This and matters similar need to have some type of resolution. The Solicitor made a point of noting that when the Borough transfers property it does so with a "Quit Claim" deed. This is done so that the Borough is not responsible for liens and gives no guarantee to the buyer. Anyone purchasing property, whether from the Borough or a private individual should have a title search completed. R. Krick said he believed that when a property is transferred it is with the understanding that a title search should be done by the parties buying the property.

#### **OPEN MEETING**

Meeting opened with the Pledge of Allegiance led by C. Marquardt.

#### ROLL CALL

Members present: J. Chiaretti, M.B. Dougherty, R. Krick, C. Marquardt, and J. Quinn Mayor J. Kelly, Solicitor E. Mika

#### PUBLIC COMMENT

Mrs. Marlene Parfitt complained to council about a neighbor's property. There was water running for an extremely long time. They contacted the water company and had the water turned off at the stop. The owner was notified but nothing has been done. She is concerned about possible damages as a result of this water leak. The porch is falling down and the pool in the back yard is collapsed. E. Mika asked Officer Collins if the property was cited. Officer Collins said he didn't believe so.

Mr. Mika told the residents present that lack of code enforcement makes situations like this difficult to remedy. The Borough has had people who have tried to do the job and found it overwhelming. Though these types of properties can be cited it can also be a civil matter. Mayor Kelly agreed to send an officer down to 244 North Second Street to check the outside and possible issue citations.

Mrs. Marie Barber (for her Mother, Mrs. Jambeter) and Mrs. Anna Lally both attended to voice complaints about the house located between them. There was a sewerage problem which was alleviated, however, the basement has not been cleaned out and the odors are affecting both of their homes. They approached the owner and he tells them he has no money to deal with the problem and lives in Ashland now and does not care. Again, Mr. Mika tried to explain that in situations like this the borough does not have a lot of power. There is no sign of this being a health matter from the exterior of the property and cannot be dealt with as a health and safety issue. It is a matter that can be dealt with as a civil suit brought by the neighbors. Officer Collins stated that he

contacted the Department of Health who sent him to DEP. DEP told him the same thing the attorney is saying. Mrs. Barber noted that she got the same information from the Department of Health. They do not handle this type of complaint as it does not affect the public at large. Mrs. Lally complained that not only is the property filled with garbage but the owner does not turn on their sump pumps and the water drains into her cellar forcing her pumps to run constantly. Also, there is garbage out front and in the cellar and the garage and backyard is a mess with dog feces. Mr. Mika informed them that the borough could cite as a result of outdoor conditions but cannot address the interior problems. With BOCA the borough can post notices and upon failure to act can take the owner to the magistrate. C. Marquardt instructed Officer Collins to take a look at these two properties. M.B. Dougherty asked, what about the middle of June, July and August when you can possibly smell it out on the street. Does that make it something the borough can pursue? Mr. Mika said that could be addressed individually at that time. Some discussion of the matter yielded suggestions of the neighbors getting together and paying the cost of cleaning up the situation as opposed to going to court. There is nothing to stop the owner from making a mess again but it would likely be less expensive. Mr. Mika did remind residents that they would need permission from the owner to step onto the property.

A similar complaint was lodged about a property on C Street. The current residents have taken off and left the property a mess. Council was informed that Beneficial owns the mortgage on the property. C. Marquardt stated that he spoke with a representative from Beneficial. They informed him that from the time the property is abandoned it takes one year until they foreclose on the property. And, even upon assuming the property they will try to find a buyer "as is" to avoid having to deal with cleaning up the mess. They prefer not to have to deal with clean-ups. In the meantime, Mr. Mika told these residents, that again, they have the right to pursue this as a civil matter.

Mr. Mika noted that in all of these matters the borough will look at the problems and determine if there are violations of BOCA. If so then the process of citing the properties would begin. The complaints are duly noted.

### PUBLIC COMMENT

Mrs. M. Carado from West Ogden Street asked about having ordinances regarding keeping homes and sidewalks in repair enforced. She noted there are houses in the neighborhood filled with garbage, problems with cats, dogs and other animals, and other problems. E. Mika addressed these questions by saying, yes, there are ordinances, but enforcement is expensive and difficult. The borough has prioritized a list of, as it is necessary to take action against properties that pose a safety hazard first. Code enforcement is not a quick, easy, or cheap process. M.B. Dougherty added that she wished we had the money for demolition but is simply is not available.

Pastor E. Stratton reminded Council and residents that October 25, 2003 is "Make A Difference Day." The youth group has planned a town wide cleanup and is looking for any volunteers. Meet at the borough hall building at 8:00 AM Saturday morning and set out from there. The intention is to work through noon time and see how much gets accomplished.

Mrs. H. Mazika, West Ogden Street, lodged complaints about barking dogs, specifically her neighbor. She added that numerous complaints to the police department result in no action. The neighbor is supposed to be fined but the dog is still barking. C. Marquardt added he would look into the matter of citations filed for her.

Mrs. Clark, Second Street, made a complaint about Doli Construction ripping up her sidewalk during the sewer line installation project. Nothing is being done to fix this. C. Marquardt told her this is a Municipality Authority issue and she needs to attend their monthly meeting to have this addressed.

Residents of East Mahanoy Avenue were present to make complaints about the sidewalk project. Tickets were issued but only to certain people. Those issued tickets felt this was unfair. The question of parking or not parking on the sidewalk was raised. E. Mika noted he could not address past practice but parking on sidewalks is against the State Vehicle Code. Council said they had tried to avoid this but would have to approach PADOT about the possibility of limiting parking to one side of the street only. Mr. Mark Billus said he filed a complaint about the tickets with the PA State Police. Mrs. S. McCoog agreed that parking on one side is probably the way to deal with this problem but asked council to remember only one side of the Avenue has access to a back street. She also added that it is up to Council to provide safe parking. R. Krick noted it is not Council's job to provide parking. This is obviously not a simple problem and State approval is needed for any action taken on a state highway.

The question next raised was about the completion of the sidewalk project. Neighbors noted that the blacktop is not sealed and water is running under the new concrete.

R. Krick told residents they had to go to the Sewer Authority with any questions about the sidewalks, as it is part of the overall sewer project and not a Council matter.

Mr. Davies raised the question of building a garage and if it were legal to drive over the sidewalk to park off the street. J. Chiaretti reminded residents they need a PADOT driveway permit. The process was explained.

Mr. Robert Ferrari approached Council with concerns about the planned installation of a play area at Richard Street and Preston Avenue. The area is adjacent to his home and he is not happy about the problems he anticipates with kids hanging out all hours. He raised the question of a zoning permit requirement with the Court House. Council answered that if necessary a permit would be obtained. This area has always been used for recreation. R. Krick added that public hearings were advertised and held as required by law. Attendance was minimal. Council saw no negative side to the use of the property for placement of equipment already secured by DCNR grants. He added that there are conversations that could be held to address concerns but the parks will be installed as planned.

Sister Stephen Anne, Principal Immaculate Heart School, thanked Council for their efforts on behalf of the children in the Borough. She noted that the children were looking forward to the new play areas that they could utilize during recess. She went on to say we need to find a way to work to find ways to make certain that everyone is protected. The question posed was, how could we keep this positive? Sister added that she was not looking for a solution immediately. There are many safety concerns in the community requiring addressing.

### PUBLIC COMMENT

Mrs. Mazika asked what, if anything, was done about the barking dog belonging to her next-door neighbor. Officer E. Hoffman reported that part of the problem is the need to catch the dog barking. By the time the police arrive, the dog is quiet. Mrs. Mazika added she stopped keeping a log of the times and durations because nothing is being done.

Mr. M. Yesalavage read a newspaper report concerning a proposed ordinance from Ashland fining barking dog owners \$300.00. Mr. Mika replied that the borough has similar ordinances. The officers can take affidavits. If the magistrate is willing to enforce based on those all well and good, more often, however, they are not.

Mr. M. Yesalavage also noted an article concerning a dispute between two neighbors over water running from one property to another. He added that the article said that Frackville would look into the matter. Council and the Solicitor told Mr. Yesalavage that his problem with his neighbor is a private cause of action. Mr. Mika added that the case in Frackville might be based on Borough Codes and the Borough will look into the matter to see if we have any responsibility.

Mr. M. Yesalavage complained that run-off from Wild Cat Road and Preston Hill in Butler Township is coming into the borough's storm system. He added that the storm drain at that intersection is filled. Butler Twp has been cleaning this drain for years but lately just drives by and does nothing to alleviate the problem. C. Marquardt said he would contact Butler Twp and have them take care of it.

Mr. H. Ressler addressed the Council as a representative of the "Concerned Citizens" group. After a very long discussion of the question of raising taxes to add police protection that proved fruitless the group was asked, in future, to limit their submissions for discussion. The group agreed to submit one or two topics to the Council in time for the work session and allow for reasonable discussion during the regular council meeting.

The possibility of forming a crime watch was suggested. C. Marquardt reminded the residents that this had been attempted more than once in the past and there was a lack of participation.

The question of borough participation in the drug task force was raised. The group was told that investigations by the drug task force are ongoing. Rarely is the borough police department directly involved. Investigations can take several years and information is not available until the raids actually occur. Any residents with questions or concerns can contact the task force directly.

Mr. H. Ressler asked about better snow removal. Council addressed this matter by saying they have looked into the possibility of making Main Street and Mahanoy Avenue PADOT snow emergency routes. There are problems with this due to the need to remove all cars at one time and the parking problems that result.
