#### **PUBLIC COMMENT**

Mrs. M. Parfitt asked Council what Council is doing about the property next door to her on Second Street. She has made complaints for several months running and it seems as if no action is taken. Officer E. Hoffman said he drove by and would follow up. Ms. J. Parfitt informed council that they have sixty (60) days to take action or she and her brother would take action.

Mrs. E. Labie noted that Mr. Mika is absent and he was to keep residents appraised to the status of the properties on Third Street. This is a fire hazard with garbage on the porches. C. Marquardt asked if citations were issued. Officer Hoffman replied he believed that Officer Monaghan issued citations against that property. C. Marquardt told Mrs. Labie he would find out what was being done.

Mr. A. Engle noted that the alley behind his house on West Ogden Street is turning into a junkyard. Various cars and trash lying around. He asked if it could be cleaned up.

At this point Officer Hoffman noted forms he has for residents lodging health/code violations. C. Marquardt added that J. Quinn along with F. Zangari is handling abandoned cars. He would pass this information along.

Mr. H. Ressler asked what could be done about the behavior at 6:00 AM. He informed Council that on his way to work there were at least six (6) people standing in the doorway of Teddy Ferrari's barbershop. They were loitering, drinking, and urinating in public.

Something needs to be done to crack down on this problem. Pastor Stratton said she heard them around 3:00 AM. Mr. M. Manbeck added he has seen similar behavior at 2:45 AM down by the bank on West Main Street.

Pastor Stratton told Council that the sign is ready to be picked up and installed. "I hope that the weather will stay nice."

Mr. J. McNeilis, AOH, thanked Council and borough residents for their support of the upcoming parade. A street sweeper is being donated to clean the parade route on Wednesday, March 17<sup>th</sup> beginning at 12:00 PM. Residents are asked to remove the vehicles from the parade route. Signs will be posted. C. Marquardt reminded residents if they've swept in front of their homes to call and have the dirt picked up. R. Krick asked how the street sweeper would proceed. Mayor Kelly assumed that it would follow the parade route beginning on East Mahanoy Avenue.

Mayor Kelly reported that no parking signs are set to be posted for Wednesday for street sweeping and Saturday morning for the parade. He met with Chief A. Bernodin from Ashland and plans for police protection are well in hand. He is hoping for ample fire police for traffic control. Three ambulances are scheduled to be on stand-by at various locations as well as fire trucks. While Mahanoy Avenue is closed to traffic, Main Street will remain open and when Main Street is closed Mahanoy Avenue will be open. This will allow minimal disruption of traffic flow through town.

#### PUBLIC COMMENT

H. Ressler noted that he had several questions that needed to be addressed by the Mayor but as the Mayor is not available perhaps the Council can address some of the concerns. These are a result of the last meeting of the "Concerned Citizens"

He raised the question of police coverage. M.B. Dougherty informed him that Council is preparing to take action to hire two part-time officers tonight. She added that police department scheduling is the Mayor's responsibility.

He asked how code enforcement would handle complaints now that the warmer weather is here. He noted that the complaints about high grass and weeds and garbage would begin to be voiced. M.B. Dougherty informed him that the current code enforcement officer works a very limited number of hours. She hoped that he would take action on problems he sees as well as follow up on reports.

He asked about how loitering is handled. It seems as if a blind eye is turned. Only issuing warnings serve no purpose. Perhaps a warning followed by a citation might curb some of the problem. M.B. Dougherty noted again that she could not answer for the Mayor and she agreed with the idea of filing citations after giving a warning. She did not know how to solve the problem of the "blind eye". J. Chiaretti noted that the officers hired here are usually newly graduated and have no experience.

The question why the borough does not participate in the demolition program was raised. The explanation to those present is that due to financial constraints no money was budgeted this year for demolition. The borough must participate through the County and even the county funding for demolition projects is smaller than in years past. C. Marquardt added that the borough is planning to pursue the owners of dilapidated properties. The ownership of the property on William and Preston that the borough tore down was questioned. M.B. Dougherty said that Council was informed the deed had been split to allow the borough to take the back portion and tear down the dangerous structures. Apparently the deed was not split as required. It was suggested Mr. Ressler discuss the matter directly with Mr. James Kilker as he was the Borough Solicitor at the time.

Complaints were also raised about residents walking dogs and not cleaning up. The answer to this problem is that you can report it to the police officer but have to be willing to come forward if necessary for prosecution.

It was noted that grants are available for housing rehabilitation on a limited, first come, first served basis. The grant coordinator is currently working their way down the list of homeowners who expressed interest in participating in this program.

Gabriel Tenaglia, GAMA member, asked if Council could explain an ordinance assuming debt for the construction of the sewer plant and lines and it is a "lease rental" ordinance. He questioned if, after paying the loan for 20 odd years, the Authority would actually own the plant and property or if it could be taken and sold at any time. He was told that the ordinances passed were boilerplate types of ordinances allowing for the interim financing of the project. The borough guarantees the debt but the Sewer Authority is responsible for payment and ownership.
