Marquardt noted the contact would likely be John Mitchell. M.B. Dougherty added it would worth talking to them about this matter.

J. Chiaretti noted that the Mayor has jumped in to assist our new streets department employee when J. Petusky quit.

SCHOOL: R. Krick reported that the big boiler is not working. TNT, the company that did the tube repairs will be in to look at it. There is heat in the gym but not the building.

OTHER BUSINESS

Mary Beth requests Council consider drafting a letter to be sent to new property owner's informing them that the borough does conform to the UCC and does have maintenance codes in place. Wording of this by the solicitor making certain it is legal. Her concerns, addressed to council is that in the last judicial sale some corporations from Philadelphia, purchased empty buildings and she was wondering if any other communities might have some similar policy in place. E. Mika noted that this is a valid concern and a letter to the effect of informing landlords that the borough does have code enforcement could be sent. The question of a vehicle was raised and it was suggested that the tax bills be used. M.B. Dougherty said she would type something to be enclosed with the next round of tax bills.

E. Mika reminded P. Teresavage that with the judicial sales, property maintenance is the borough's responsibility. UCC covers all improvements to property and the Property Maintenance Code covers maintaining property.

E. Mika had suggested that the borough consider pursuing purchase of some of the properties up for judicial sale. Consensus is that it would be nice to have the lots but no one would be interested in purchasing them. M.B. Dougherty said she requested a listing for the April sale and informed residents they could review the lists at the court house.

Mrs. Labie, could not attend the meeting this evening, asks that all the organizations in town planning something for the centennial hold a combined meeting to review dates and events.

Mrs. A. Gross complained that you can never reach the permit officer. J. Chiaretti said that he was aware of that being the case. A letter is to be sent addressing her lack of availability and asking if she is still interested in the position.

Mr. T. Clark spoke about the rash of fires and asked if anything is being done about the burned out buildings. Letters will be sent to the property owners noting the need to proceed with clearing the properties.

Mrs. Kanagoski complained about the coal trucks speeding up and down Main Street. Mayor L. Kachelries noted that tickets have been given to trucks for speeding and he is working on a schedule to have an officer out in the mornings to slow the traffic down. M.B. Dougherty suggested doing a BLITZ, be out one or two hours a week on different mornings for a couple of weeks and that should cut down on the speeding.

Dougherty said she would get the money when the building is down. Mrs. Gomosky told council that that, since moving into the borough, she and her children have constantly been harassed. She believes her building was set on fire but no investigation is being done and she is going to Washington DC for an investigation into this matter.

Dougherty said that the spaces were measured from the corners for uniformity and spaces left at the driveways for safety. M.B. Dougherty noted the following recommendations for changes to the borough police department policies:

Schedules will be set on a monthly basis. The Mayor sets all shifts. Premium shifts of 8 hours on Thursday, Friday, and Saturday between 7:00 PM – 7:00 AM only with a pay rate of \$12.00 for any officer beyond the ninety (90) day probation period. If two premium shifts are missed without valid reason, the officer will no longer qualify for the premium rate. Daily logs must be completed and hours fully documented by the end of each shift. New hires will have a starting rate of \$9.50 per hour with a ninety (90) day probation period. A 50 cent raise after the 90 days

upon the Mayor's evaluation. The police department will operate on a 48 hour week due to the rate increases. All time sheets must be completed and handed in to the secretary the Monday prior to the pay day or pay will be withheld until the next payroll cycle. Motion to adopt the preceding made by R. Krick, second J. Quinn. Vote. All. Motion carried.

Motion to increase Michael O'Neill's pay rate to \$9.50 beginning with the 8/6/07 pay cycle made by R. Krick, second J. Quinn. Question? None. Vote. All. Motion carried.

Motion to hire Charles Koveleski upon the recommendation of the police committee with a starting salary of \$9.50 and a 50 cent per hour raise upon evaluation after ninety (90) days made by M.B. Dougherty, second R. Krick. Question? None. Vote. All. Motion carried. Mayor to notify new hire of offer.

M.B. Dougherty noted that Ringtown Borough, through the COG is interested in doing a survey of the local police departments regarding pay rates, uniforms, hiring policies, etc. R. Krick suggested looking into utilizing similar uniforms and sharing costs of things like firearms qualifications.

C. Marquardt brought up the problem with the mine drainage and the storm drain on Main and Silver Street. R. Krick noted that he contacted D. Cuff, Entech Engineering and PADOT to look at this problem. He asked who makes the call of closing Main Street if the damage migrates further out into the cart way. No satisfactory answer from PADOT. He suggested sending a letter to this effect directly to Allentown. This was put on hold until the matter was further investigated. C. Marquardt suggested placing a steel plate over the damaged drain to allow traffic safer passage. Council agreed.

P. Teresavage asked if he could have the police schedule as he sometimes needed an officer.

On the matter of Ida Gomosky and the building at 19 East Ogden Street R. Krick informed council that she claimed to not have been able to reach T. Niedzwiecki to obtain a demolition permit. This is what held up tearing down the building and now there will be an additional 2-3 week delay.

Questions about the safety of the buildings located on the corner of East Main and Second Street and between Tony's Lunch and Centioles' were raised. P. Teresavage is to look into both matters.

Question of abandoned vehicles was raised. R. Krick said the borough should try to contact the owners and if no response have them tagged and have a bonded salvager come in and remove them.
