PUBLIC COMMENT

Rats: A. Cress complained that she has rats in her home because of the neighbor. J. Wilson said that he was there, at 209 E. Mahanoy Avenue, the yard was cleaned up and they were starting on the house so he did not cite them. A. Cress said that there have been complaints prior and she wanted to know what is taking so long. J. Wilson said that 207 E. Mahanoy Avenue is where the people used to live. This property is being cleaned up. They have no rats. They have dumpsters on site and will have more as necessary. He was instructed to cite 209 E. Mahanoy Avenue, if there are things that can be cited. Let the magistrate issue fines.

Alex Gregis complained about problems at 396 West Main Street where they put up a pool. E. Burns said they need a permit for the pool. Setbacks, however, would be a zoning issue. We will have our inspector check into this matter. Any violation will result in the pool coming down. Also, A. Gregis complained about his running a business out of his garage, banging ladders and such. J. Wilson will check to see if there is anything about this in the codes.

T. Clarke complained about 109 - 111 - 113 - 115 North Second Street have all been sold this past month. Can we get them inspected and the grass cut? The inspection will have to wait until they are rented but the grass can be cut. J. Wilson will check into the owner and notify him.

Also there are mattresses down by the playground by my house. The neighbors tossed them out. They have bedbugs. T. Clarke will talk to the officer tonight to file a report. Officer Weaver will go down tonight to have them moved.

D. Cress complained that he has neighbors who are buying houses, "rent to own", and turning around and renting them to someone else. He asked if this was legal. C. Marquardt said that we would have to check this with the solicitor.

M. Long complained about the neighbor's house, the Tyson property, and all the problems with the building. She has no insurance because of the condition of the property. The owner takes no responsibility for it at all. He has said he'd rather go to jail. M. Long said this has been going on for fifteen years and something needs to be done. J. Wilson said he cited him and is waiting to hear from the magistrate.

M.B. Dougherty said that with the blight law it is possible to go after their personal assets and that will be the only thing these property owners understand. M. Long asked if it was legal for an insurance to deny insurance to someone because of the next door neighbor's property. M.B. Dougherty told her that it was a fight and there was a lot of lobbying with the assertion is that they are not denied but rates as very high. As a result it was dropped out of the bill.

T. Clarke asked if they were going to do anything with the burned out houses on West Main Street. J. Chiaretti said that the contractor was attempting to get bonding so that he could proceed. If not, the Borough is looking to filing a lawsuit against him.

D. McDowell asked for permission to solicit donations to pay for some equipment and a picnic for the kids who play in their informal soft ball league. He was told to draft a letter on letterhead and submit it next month for review. Also, there is a question of being able to use property next to the school because they do not have a yard or a front porch. He asked if they could make use of it. Council gave him permission.

T. Yesalavage, GAMA, asked Council for permission to hire Jeff Wilson to go into people's homes to check for compliance with the connections to the sewer lines. We would like to hire him, through the borough, like we do M. Ambrose. R. Krick said that the question is if J. Wilson is an appointed official or an employee and that question would need to be addressed by the solicitor. J. Chiaretti asked about the time demands upon Jeff? T. Yesalavage said that it would be up to Jeff because the Authority will pay him per unit. J. Chiaretti said doing this over a 2-3 year period is okay? T. Yesalavage said yes. We would like to start this tomorrow. J. Chiaretti said there is an issue with administration and we have to do this the right way. This means asking the solicitor for an answer. It seems to not be a problem.

Recycling: There have been issues with garbage being left. We had an offer from a resident to purchase cameras for the recycling center and they will be recording. If you are caught you will be cited. If you go to the center and it is closed, please take your stuff home. Please do not throw anything on the ground as it makes a mess. Mr. Henry Wayne is donating the camera.

PUBLIC COMMENT

Question? What is EIT. The Borough needs to do a new ordinance because the County is requiring us to have one collector County collector instead of each municipality having their own. The Earned Income Tax ordinance will allow for this.

Richard Heister – 210 B Street. Have a complaint about his neighbor. They have five dogs, four chickens, five ducks and a significant stench. I have called the code officer and nothing has been done about it. Do we have an ordinance concerning pet ownership. C. Marquardt said that there are three similar complaints and I gave the ordinance to our solicitor. The solicitor said we can use the current ordinance and allow the code officer to issue citations, as many as necessary. Mr. Heister said that he believed it was only for dogs. C. Marquardt said that one ordinance is only for dogs and one is for any type of animal.

On another issue there are neighbors who believe that the liquor establishments on Second Street are a nuisance. I have lived here four years, police have not been called every night which is necessary to be classified a nuisance.

E. Burns noted that he thought the fines should be raised. C. Riedlinger noted that if you fine people every day, a fine of \$25.00 adds up.

Joseph Maucilla – 259 West Main Street. Discussed the current zoning map and how the Commissioners were taking away our rights. J. Quinn interrupted him by adding that he has a property on Main Street and has done nothing with it for years. C. Riedlinger added that this board can change the zoning in the Borough if they so choose.

Dan Cress -230 North Second Street. The bars on Second Street cause problems for everyone. Noises all hours of the hours. People coming out of the bar at 4:00-4:30 am. This last event, the police officer being shot, the owner says I have nothing to do with it. I have tried to take him to court and he turns around and pays a fine instead. I want the place shut down.

Daniel Krynak – North Second Street – I live across the Street like D. Cress does. I sleep right across from the bar and cannot say that I have ever been awakened by anyone coming out of the bar or lost any sleep because of the bar. My take on this is that it is not a problem. Bars are going to have problems.

C. Marquardt said that the Council would take the issue about the bar to the Liquor Control. This would be the safest thing to do.

Daniel Negron – 217-219 North Second Street. I own the Second Street Pub which is the subject being discussed. I have a breakfast license. In regards to 4:00 am and every weekend, not so. J. Chiaretti asked if you have someone in your bar who is obviously intoxicated what do you do? D. Negron said we do not serve them. We will give them water and a ride home.

Thomas Downey -365 Preston Avenue. I remember, growing up, that there was an ordinance that did not allow more than three people in a group. C. Marquardt said, we have a not loitering ordinance. It prohibits people from obstructing ingress or egress of any building.

Jacqui Christman – 101 East Main Street. New to the area. It is good to see so many people here tonight. You should join the Crime Watch or PRIDE to see what you can do to improve things in town.

Debra Downey asked if Council received her letter and if so could it be read. C. Marquardt noted it had been received. Phyllis Gallagher – here is support of the Downey family. The letter basically said that we need law enforcement for everyone in town. J. Chiaretti said that we could have full time police officers but like the City of Philadelphia we would still have robberies and shootings. The police arrive after the fact. It would do nothing to prevent these things.

Kandi Cope – West Main Street. I have been here for two years. My house was robbed in broad daylight. My son has received death threats. My brother was missing and found in a hospital. Gossip is gossip. I am new here. We protect ours, we protect our neighbors but not everyone does. The stole my gold, our money, my husband's 30-30.

which is on the street somewhere. We don't rob people. This town needs to get together and take care of our streets.

Helenann Brennan -310 West Main Street. She said that she heard that Frackville has an occupancy permit and asked if it is something we should have as well. She was told that we do have an occupancy permit. J. Wilson stated the necessity of getting a permit but people do move in without them. She was told, if you see someone moving in, notify the borough and it will be taken care of.
