Sharon Gower adds to many people are not following the yellow lines of the corners. They are out of town people coming to these games and why not ticket them? E. Burns stated to get D. Heiser over at the school. D. Heiser wants to send the children home with a letter to parents about parking and give warning of enforcing tickets for any parking violations.
- 2. D. Heiser added to send the letters to both churches about the parking. Heiser said someone is going to get killed coming out of St. Joseph when mass is in session on Sundays due to visibility. C. Marquardt added I'm sure if we send a letter to Father Connelly he will address it at the mass and we can have a cop out there to enforce it. Sharon Gower stated letter should be to both churches; again they park to close to the yellow lines. E. Burns comments that goes along with police enforcement at these games, at the churches and be a little bit more notice able. Mark Rainis comments the police force does a nice job but, could be enforced more we have a brand new police vehicle paying for and he never see's it when kids are coming home from school or have activities the police presents should be know. Rainis never see's a full time cop at these events and the parking would not be as bad if people knew the cop was on duty.
- 3. E. Burns announced after public gets knowledge of the parking. It will be enforced 100%. Sharon Gower thanks the Mayor. Burns says normally a cop is on Mon, Tue, Wed. D. Heiser adds after basketball next week the child will be sent home with a letter that we are going to get stricter and enforcing the parking violations.

Couple of business in the borough now who are interested in putting a float in the parade. This is good. Any questions Barrett left card to email or check out the website. A lot of information about the parade is on the website. A map and couple of information doing the security and safety is also on the website. Again we are going to have hand radio operators they will be positioned throughout the parade route. To keep eyes and ears on any problems we see. Such if a car breaks down, a float, or unruly people. That is another thing Barrett wanted the community to know. Help me and hopefully help the police officer. If you see any unruly people or anything going on we want you to be the eyes and ears. Contact the communication center and let us know we'll be able to deal with it. A lot of complaints of people from in town and out of town some of the unruliness that is what I'm trying to prevent. This is a family organized event. We want to keep it that way. That is why I am asking the community for help and helping us out. The parade clean up of course the guys are putting signs out and clean the streets. Help us out move the cars. D. Heiser did have a suggestion, talking about sport Cardinal Brennan closing this is the last year for the Immaculate Heart Hawks. That's been a basketball program that's been forever. Reach out to them, Dominick Grosso maybe the guy you want to talk back to. Maybe they want to put something in the parade since this is the last group of kids that played this year are the last ever to play. Barrett we are going to try that. I might come up with a press release instead of the newspaper, new item. Try to invite more schools participation. A lot of them don't need to worry about the play-offs now because their

knocked out. We're going to try and give people more push. The weather we are still in winter mode and get people interested in coming to the parade. Next week hopefully Friday we're going to have the parade line up. The parade line up will be in the parade website. Barrett question for Council two issues with the parade. Communication we should be ok. Down at the Hibernian House after the parade we should have some kind of law enforcement. Want to see somebody down there so we can communicate with. Another was B Street we had an issue with traffic the buses were coming up B Street. It is not a parade route and may not be a priority to clean the snow but if people park there and with the buses coming up the street was a problem last year. Maybe making one side of the road no parking this year. Otherwise nothing else is going to change.

- 2. Christopher Riedlinger, at the request of Jeff Fesser Schuylkill Community Action will be administering the Keystone Communities Program Grant that the borough is receiving for the West Main Street Project. He requested that we draft a resolution. Authorizing the execution of the contract and appointing one or two of the Council members to sign any other documents on the grants on behalf of the borough. C. Riedlinger drafted the Resolution No 2015-2 approving the Keystone Community Program grant contract and authorizing the president or vice president of Council to sign any related documents. I am going to ask Council to make a motion to approve the resolution. Then I am going to have Charlie and Joe sign the contract it's self and I'm going to send in to the DCED tomorrow sometime. C. Riedlinger asked M. O'Connell to sustain making a motion on this because there is a second grant, federal home grant coming in that the county may act as the administrator on Schuylkill Community Action prohibited from acting as the administrator on that grant and the county may ultimately may act as the administrator. Because Michelle position with the county and her association with Gary Bender. Riedlinger is in the process of getting an option from the state ethics commission whether or not that is a conflict of interest and until that option comes through I think that would be wise for Michelle to abstain from voting on anything relating to these until we have that opinion. C. Marquardt needs a motion to accept Keystone Grant Motion to accept the report as submitted made by R.Miller, seconded by D Heiser. Vote. All. Motion carried.
- Vote on Resolution No 2015-2 authorize the approval of the contract. Motion to accept made by D. Heiser, second by J. Kessler Voted. All. Motion carried.
- 4. Riedlinger, I don't know if this is a part of this or have it on a separate agenda item but while we are on the topic may as well also do. Although if it looks as if the county is administering the home grant if the money does become available. Jeff did suggest making a motion to procure advertising to procure a consultant in case the county isn't going to administer. We don't have to wait until April to get a newspaper ad out asking for consultants to send in proposals. May be Councilmen should make a motion to advertise for the procurement of an administer for the home funds. That way if the county isn't able to do it we can get an RFP out ASAP. Marquardt, and the reason for this is talking them from DCED Mike Carpenter and so on. Candice submit her resume into them and they felt that she needed an additional training and stuff which they do offer, but with the timeline of the grant they felt that we'd be better off suited if we had a consultant. Jeff got two consultants. One was Karen Parish and the other was Faith

- Rickert. In the process of that they both called me. I guess Karen was with Michelle but both of them called me and so if in fact the county doesn't but we're pretty sure it is. I'm pretty sure Karen Parish outfit will, they are familiar with it and they will assist us with it. Reidlinger, just to be safe. Marquardt, to be safe we have to do that and make a motion whoever we appoint if the county doesn't. Motion to hire consultant and advertise to hire a consultant for the home grant. Motion to accept made by R. Miller second by D. Heiser. Voted. All. Motion Carried.
- Request for parking ticket money for the police car fund. J. Kesser, any parking ticket
  money comes to the borough will go into the Police Fund for the Car. It's not going to be
  a great deal of money but it helps. Motion to accept made by R. Miller second by J.
  Kesser. Voted. All. Motion Carried.
- 6. New Truck, Riedlinger, I have a resolution that I drafted and numbered 2015-1. I also have a document that the USDA U.S. Department of Agriculture asked me to have approved for them it's called a resolution but it's not an official Borough Resolution it's just a document that the USDA would like adopted for their purposes for their records. I drafted the resolution necessary to authorize the small borrowing for the purchase of the dump truck and plow the majority which is being paid for by a grant. The borough is borrowing to fund the rest. The loan will not take any longer than five years to repay. The interest is 3.75%. The resolution authorizes either the Council President or the Council Vice President to sign any documents necessary to finalize the loan. The closing is going to be scheduled by Tonya St.Clair of U.S. Department of Agriculture. It's not scheduled vet. I anticipate before the April meeting I do not know the date yet. R. Miller, she called next Wednesday she is going to call for a time. Riedlinger, I'm going to be honest, I'm going to tell her if she wants me there. Whether if I'm there or not doesn't matter to me, but if she wants me there. That's not going to be possible for me. I'll be out of state on vacation next week. I'll let her know that when she calls me. I didn't know that she hadn't told me that when I last spoke to her. Maybe it will be next Wednesday if she doesn't mind my being absent. If not it will be rescheduled to a day when I get back. Resolution 2015-1 authorizes the borrowing I need Council to vote to approve that. Motion to adopt Resolution 2015-1 borrowing for new borough dump truck/plow made by R. Miller second by J. Kessler. Question by D. Heiser, how much are we borrowing? Riedlinger, \$22,500.00. Voted. All. Motion Carried.
- 7. Riedlinger, a related document it's couched loan resolution. It's an official USDA document Tonya St.Clair and Department of Agriculture has asked that we have adopt this. It contains many of the same previsions as own resolutions I looked it over there's nothing in it that causes me any concern it's basically authorizing the loan in the language the USDA wants as supposed to my resolution which is the language the DCED wants. Motion to vote to approve the USDA loan resolution and authorize Charlie to sign it on behalf of the borough made by D. Heiser second by R. Miller. Voted. All. Motion Carried. Related to the topic R. Miller, we got the plow for the other truck and put into the deal. D. Heiser in case the public is interested the truck was \$50,277.00 the plow was \$4,750.00. Spreader was on there to like \$6000. In the \$56,027. The grant we're getting is \$33,527. We're borrowing \$27,500. Monthly payment \$412. Krick, what is the increase for the insurance cost? Miller, not sure. Krick, did anybody increase the budget for the insurance rate? Miller, we still only going to have two trucks. Krick, you're going to keep the other dump truck? Miller, I don't know what we are going to do with that yet.

- Krick, I'm just wondering what the insurance is going to be. Miller, we haven't talked about that whether we're going to keep it or we're going to get rid of it no one talked about that yet. Dougherty, can we talk about the insurance either right. Do you talk about anything?

I don't know if community action is going to do anymore projects because of this. Like I said I stood on the board I know it firsthand. I spoke to Jeff Fesser he was not happy. That you guys sat on your hands and let this sit. From what Dougherty understands the letter was dated January 9th it should have been acted on in February. Riedlinger I'll be honest with you Marybeth if you are asking me the question. Dougherty No I'm not asking you the question. Riedlinger I'm not disputing anything your saying Jeff has never expressed to me anything like that. Dougherty I mean quite honestly we had a good working relationship with community action, it just pisses me off Senator Rhoades started this whole thing in 2007 in this town and you're going to screw up a good working relationship with community action. Because who ever opens the mail did a piss poor job. It's upsetting and you're screwing up a good relationship with the community action.

Dan O'Connell Mr. Burns why are you sitting there laughing when somebody is talking? Burns how do you know I'm laughing at them. Dan O'Connell you're sitting there just giggling the lady is talking I'm we're tax payers and it's like you guys aren't listening, this one is with his

head down. I'm enough is enough like she said we're going to lose big time. We have two people here that want the town to move forward. There it is. Burns I don't do nothing I know I don't nothing I'll I do is giggle. D. O'Connell you're sitting there with this stupid grin every month. M. O'Connell do you want me to tell you something I am going along with Marybeth that project made us look bad. It made me look bad and how discussed I was. When I first got on that board. Got brought down that job Girardville was my first project I was sick last week when I heard about the contract being lost and I am going to agree with Marybeth. D. Heiser says, Marybeth Michelle Joe Charette a lot of people did put a lot of effort into that project. Kind of looks bad for us. M. Dougherty I'll tell ya Eddie can sit there and smirk all he wants I don't really care. I'll ask him about this particular one and Champ Holman was at a meeting here last year saying he supported it he wanted to help the town. He and I sat up the Dutch Kitchen last January, me I have no skin in the game anymore in the town I'm not up there with you guys I have no skin in the game other than working with Dave Argall who was supported in all this stuff. Asking community action how we can help Champ Holman get the applications in before I leave I will do my damnist to make sure Girardville gets approved worked it to make sure it happened and you know I get told my people at DCED now that they didn't get the contract back from Girardville in a timely manner. Marquardt well in response to all of this, yes the letters did come in yes they went unopened. Yes I will take responsibility because I never saw them. Dougherty, let me defend you for a little bit it worked for years with mail and process procedures around here we never have this problem Charlie never. C. Marquardt we are going to change that procedure. That procedure is going to change effective immediately probably since the mail is being delivered here to this municipality there will be a mailbox put outside. The mail will be distributed in the mailbox. The only persons with keys for the mailbox will be Candice and myself. And I'm sorry Joe Kessler will also because of the absent of either one of us in case the police needs the mail. The only time we go into the box is in Candice's absent. Candice is going to take full responsibility for the distribution of the mail. Dougherty why did it get changed? Marquardt, it got changed because when Mary left and when we changed the so called picking up the mail at the post office. Because the post office changed their hours, Rick volunteered to get the mail and bring it in and distributed it we did not think it would be a problem at the time and the mail was distributed naturally over the course of time all the mail everything coming in trying to train Candice all the other stuff this is what happens. We found mail in the police box and I am the President of council and I'm going to tell you now I am going to take the hit for it all. Because I have to make decisions now and it is on fortunate and I might piss people off but that's what is going to happen. Dougherty, you do what you got to do Charlie you're the council president. Marquardt, but I talked to Jeff Feeser when he called me I was very upset myself because I did not see it. I called everybody to see if they saw it. I had Candice tear the office apart. We found it. I called Jeff. He called. We called Chris and we got it processed and hopefully yes it will go through if it doesn't I probably don't have a thing to say, but I would step down from this council seat. Dougherty, honestly I'm not blaming you Charlie it's not your fault. Marquardt, it's not

necessarily my fault it's everybody that sits up here on this board but the idea is I'm the guy that is in charge of everything. So I got the mail was addressed to me. I'm the one who should have got the mail. Dougherty, wasn't it put in your mailbox? Marquardt, it wasn't in my mailbox it was in the other mail box on the bottom. I have two mailboxes because I get mail on the top and bottom because I have different reports and stuff and was always like that between me and Mary. The important stuff goes on top, unimportant stuff goes on the second thing; unfortunately this envelope was in the bottom box on the bottom. I don't know how it did, I don't know what it did, I have a big problem with and I will not blame anybody but, when Candice is distributing the mail, whoever was distributing the mail. The mail goes in all their boxes and you know where all the boxes are in there. Seems funny to me that someone goes in there and looks threw people's mail in those boxes. I don't know who it is yet but I will get to the bottom of it. Marquardt, I mean if the mail is addressed to a particular council person it goes in their box it's their responsibility to act on it and present it to Council. If mail comes in directed to Council it's self or care of secretary Candice has to act on it. That's the way it goes. It's Candice's job to tell us what's in the mail. Whether it's a bill or whatever it is she has to pass the information on to the finance committee and they have to plug it in to the accounts. Heiser, Rick there was no, I never heard a word talked about it. Miller, last year I tried to get it resurfaced I tried to get grants I had gone to three different companies come over here and give us a price. Male, I agree with you Danny there was no talk of fixing those courts for our kids to play on. Another male, their adults let them chip in \$10 or \$20 bucks a piece they're the ones benefit by it. Heiser, Yes I understand both have a fundraiser to pay for it but call me goofy or whatever but shouldn't you have a fundraiser to pay for something before you do it. Heiser, honest to god I firmly believe 100% those basketball courts would have not be fixed if our kids we're the only ones using them. Heiser, and that's fine there fixed there done there nothing I can do about it. It was a project just like anything else we start digging we run into problems it cost more again I understand that but I just think the people have the right to know that it wasn't what we said it was going to cost initially. Even if we get reimbursed even if the raise enough money to pay us double what they cost. That's great but it

didn't cost \$250.00 Gower, we were missed lead. Dan O'Connell I'm talking about labor rental this or that and that's were Danny's stalling. Miller, the running it with the crew originally but Mike estimated three ton of anthracite we used six. O'Connell well shouldn't have yours went out there and went over with Mike or just take the guys word for it. I mean common sense say you get an estimate on the work your salary rental equipment like Danny said all you talked about at the last meeting was \$200 and sum dollars for macadam which sounded great but now the bills are coming in now equipment and the guys are 8 O'clock at night working that's overtime. O'Connell I Mean I'm not taking their money away from them ya know, to get overtime fine but that wasn't figured in this guy just sat there and said 200 dollars for macadam and that's it that's all that was discussed here last month. Gower, they mention about a rental and it was only going to be ninety sum dollars or something. O'Connell then I stand corrected but that was it. Miller, they cut it with what they originally rented was a saw to cut it and when they cut it they found big craters underneath cement big cement block underneath it. Labie, you run into projects no matter what you do even run into problems in your own home. O'Connell, what are you going to do about this here, you should have looked at what about this that's common sense it wasn't really planned right. You guys just wanted to go and do this court. O'Connell just like he said I have no problem that you pay them for it, just wasn't thought through. Heiser, six hundred and five dollars just in material and equipment. O'Connell, and that's the borough's salary. Heiser, plus the guy's salary. Heiser, just trying to clear up the fact that well over budget and I don't have anything against anyone playing basketball in that park. My point is I believe full heartedly that if the adult league was not coming to this town to play those courts would have been just the way they were all summer long and they would have been fine. That's my belief I'm entitled to that. Male, you are totally right, absolutely right. Another Male, the adult leagues play anywhere else or just Girardville. Heiser, they play other towns Pottsville, Pine Grove. Male, let's see them use it but like I said their adults they should be able to kick in a couple dollars apiece to the courts. Miller, some of them are in high school. Male, they have parents and they guy playing down there didn't look like no fifteen year old kid when I went by to dump off supplies to come here and probably half of them went to the bar and dropped fifty bucks so come on Jesus Christ they can't spend twenty dollars towards the courts that's bullshit. Another male, maybe you should incorporate that next time they play to give so much towards the basketball courts itself. Male, if I were playing I'd gladly donate twenty dollars. There will be quite a bit of tax money coming in yet. My fear I just was thinking maybe, it's something we have to pay. Could we pay half now half later? Male just by listing to what you're saying doesn't sound good. I mean I don't know what coming in anticipation just what you're saying to the public doesn't sound good. Again male, financially we are only half way thru the year. Heiser, and I do believe a majority of our taxes has to come in is that correct? Miller, no we did get 100,000 dollars off of it we are anticipating \$140,000.00. Heiser so a majority of taxes did not come in expected \$40,000 more. Miller, we are our budget but the County is a little higher. Heiser, my question is there any problem paying half of that now and other half in Sept. I know we have to pay it but if we cut ourselves thin and wait for tax money to come in that's what put us in the position last year correct. Kessler, what we did last year they paid tax anticipation note in the sum of \$45,000 all at one time they only ever made one \$5000 payment then in June decided to pay the full amount \$45,000. Miller, not a problem but then is we going to have the money to pay it at the end of the year. Heiser, I do understand fully that it has to be paid. Yea that chance does exist that if the tax money don't come in we'll be. Male, same position.

Wade, whatever happened to that Medical Center that was supposed to go in is that a dead issue or is that still on the books? Riedlinger, I haven't heard anything about that in months. I have no idea if it's a dead issue or not. Wade, there was a lot of money up for that. Riedlinger, the last time I was involved in discussions about it my understanding was the groups that was trying to put it together were trying to get funding I don't know if they ever secured funding my suspicion I don't know this but, my suspicion is they didn't or it still would be discussed. Male, you'll have to get a Girardville Team sweatshirt out again for. Heiser, last I remember coming to a meeting for that was the end of fall last year, that meeting they had state that Geisinger was on board and they were going to fund project and everything. I have emailed on several occasions and I have not got a response. Male, last I heard they don't have a lot big enough for what they were planning on doing. Labie, they did down size their original plan. Heiser, I will look into that and try to get you an answer for next meeting. Male, does the borough get paid for cutting the grass down there at the Medical Center lot? O'Connell, yeah who owns the lot? Riedlinger, my understanding is we own the lot they wanted we. Male, no that was deeded over when Joe Charetti and all was on the board then they dead the section of the land between park and little league field that section in there and they were going to move the court across the street over here. Riedlinger, I'll be honest with you I don't want to state this completely for the recorded cause just going based on my memory I'm not 100% sure I'm right, I don't think it was ever formally deeded. I think there were just discussions that it was going to be done but, I don't think it was ever officially done. Labie, is it in the paper the deed transfer you have to look that up and

find out I don't recall. Heiser, look in the parcel locator. Riedlinger, I don't recall ever drafting the deed I know that we would want to have a reversion clause in it. If this property wasn't used for the right purpose. Labie, I was down the courthouse when they had the hearing to see if we were approval it, for it to be put we had no aptations to it and I remember Joe Wayne he was there my son and me nobody else of Girardville at it. New venture is targeted 106 to 118 West Main Street where the fire back 2012 destroyed few homes. Demolition is completed, asepses removed. January good news about Pennsylvania Department Community and Economic Development approved the \$500,000.00 Keystone Community Grant. In the middle of June last month received news that \$500,000.00 Home Grant was approved. Being reviewed for Larring Under Writing Analysis probably take another thirty days. Then documentation will be sent to the borough that J. Feeser will be completing for the borough to send for approval, if successful grant to be executed and will be \$1,000,000.00 for the project. Few things need to be done prior to that. Another thing to discuss tonight a resolution, Schuylkill Community Action named administrative agent on the Keystone Community Grant we'll take care of the paperwork, invoicing, things like that in conjunction with the Keystone Community Grant. The home grant which is conditionally approved there's been initial paramilitary conversation with the County of Schuylkill with the grant writer as far as them taking on the administrative agent for the home grant. Any questions about the project? Feeser, we have some architectural design work done on the plans on what the site will look like. SCA has invested about thirty eight thousand dollars so far in the project, the demolition, procurement of an architect, and things like that. Labie, they are two

story homes. Feeser, be a basement level and two stories on top initial designs are calling for. Most part will be four units from road level up and are three bedroom units; lower level hope to make those two units has ADA assessable units and probably will be one-two bedroom. Public comment, any job openings for Girardville residents? Feeser, we procure a general contractor, we have to put it out for public bid. We do not know at this time who will be the general contractor but, everyone will be made aware of in the borough at a council meeting who the contractor will be. What will probably happen that point in time the residents will be able to contact the general contractor. There will be a lot of opportunity for work sometimes they bring in their own crew and sometimes they hire but, it will be up to the general contractor to make that call. Public comment, are homes for sale or rent. Feeser, for rent. It's affordable rental development project. We completed five single family homes that had been sold and the S. William St the three unit townhouses style we own manage and rent. Male, are any of these properties on tax growth? Feeser, there was eight parcels and I believe five of those came through the tax claim bureau where there was no taxes paid for many years. I just did an analysis last week on the development we done completed in the boro and five homes and the three unit rental all paid real estate property taxes and school district generated almost \$10,000.00 annually in funds to the school district. I don't have a number on what it meant to the boro. Someone had told me it was equating to a mill from what I was told. Public comment, what about the permits? Feeser, yes absolutely we have to pay the permit fees and everything yes.

Dougherty, why does the borough have to have fund raisers for stuff? Is it poor budgeting poor planning? Marquardt, could have budget for one thing and have to use it for another. The guys turn around Eddie did and decided to have fundraisers so we didn't have to take it out of the

general fund. Same thing happened to the Police Car. Dougherty, people pay takes you have fundraisers and spend more money when if was something you planed appropriately and budget appropriately. Heiser, we should of raised the money then repaired the courts not repair then raise money. Catizone, where does that money come from? Heiser, Came from the borough tax dollars. O'Connell so you have more renovations to do what if someone gets hurt right now and not completed? It looks like a poor horrible. Should that be shut down? Heiser, sealing it doesn't affect the basketball courts sealing just going to prevent the winter from when it freezes just has to be a warm sunny day. Soucheck, the basic renovations are done just has to be sealed. Heiser, never applied for that grant because we did not have that money to get it right they need to be torn up and up to codes.

### PUBLIC COMMENT

Tom Clark 103 North 2<sup>nd</sup> Street. Is it possible the next borough Council meeting to project the cost in knocking down five houses a year for the next couple of years. Reason I ask is people think the demolition period is coming to knock these houses down just to show the impact on our property tax will be. Let's face it we'll have to increase the millage. I believe it will help the people understand why the houses just aren't going down, there just isn't any money. J. Kessler you're talking about five billion a year Tom, \$5,000.00 a year. Tom, oh I'd say more but if you break it down in millage so the people understand. J. Kessler, looking at four or five Mills increase to come up with the funds to do this demolition. Tom, a lot of people don't realize there will be a Mills increase to knock all the houses down. D. Heiser, I also agree that people would

be ok with the tax increase to see houses coming down every year. C. Marquardt, our solicitor Chris just made a comment that there are other costs involved. C. Marquardt, it the solicitor to do research, engineer's involved. C. Riedlinger, it does require a trip to the court to get a judge's permission to tear it down because you don't own it. Engineer has to be involved as a witness because somebody has to testify that the property dilapidated condition and the court would subjected it property transfer to the Borough. Tom Clark, I know the finial cost is more than we realize but that's where we are now and I like that gift. D. Heiser, These homes are owned by somebody Chris can't we cite these people and then do that 12 month 18 month thing and then let the police cite them criminally for public nuisance and force them to tear these houses down. C. Marquardt, I think Rick and Jeff ran into the problem some we can get and some that have these properties the owners are out of state and are hard to find threw the magistrates office they issue warrants but we have no idea sometimes where these people are located. Edna Labie, their probably blight, opposed to start doing something if you see them working on stuff you can extend the amount of time they have, I mean work with them but there are how many of these places that they aren't doing anything. Public comment the bank owned properties we know where they are go after the banks. Marquardt, the bank doesn't own that property. Marybeth Dougherty, bank issue here brings up a good point Minersville just passed I have a copy for a registry for closed properties, includes a closure clause to appoint a manager if a bank is starting a closer. Pottsville starting to meet with their landlords one meeting is August 25th talk to Tom Palomar what they have done in Pottsville is come up with a plan, the top 10 worst properties and be smart with the money they have available. You need to start with looking at the judicial sale and the repository. If there are violations you can argue repository before the sale. Need to start citing. D. Heiser even though we don't get the money out of them, there will be a paper trail. M. Dougherty, a lot of conversations is about money but you need to find creative ways to work around it. C. Riedlinger, Marybeth correct me if I'm wrong there is also if somebody gets cited under a local property maintenance code a number over four times and they still haven't fixed it you can ask the District Attorney's office to file criminal charges. Marybeth, that just decreased to and takes effect in September I think there has to be convictions.

C. Marquardt, we received notice of Judicial Sale of three properties coming up in October a time and date is not yet available. C. Riedlinger, they already gone thru the repository sale stage and didn't sell and the county is still holding them. The county is petitioning them to go thru a judge to allow them to be sold at a judicial sale to be sold free and clear of all such as leans and things. Repository means you would buy with leans attached to it. Judicial means you would buy without the leans attached to it.

D. O'Connell, did anyone look at508 and 510 E Mahanoy Ave? It's falling down, it's in repository. J. Wilson, we talk to that owner and the chimney is pulling from the wall and I have been there before. C. Marquardt, if you have come into contact with him now just cite him. C. Marquardt, we have to take it thru all the channels. C. Riedlinger, by can't by law to have soul power to just determine which house to knock down we do need a judge to intervene. We can't write a law that just give us the power to determine ourselves if a house is in a dilapidated condition enough that we can just knock it down without a judge's permission. D. O'Connell, did anyone look into the bank where the old Acme used to be that building is falling down someone is going to get hurt. D. Heiser, I believe we did try to inquire that and the guy would not sell. C. Reidlinger, the district justice determines the fine we can't decide the fine amount. D. O'Connell what is the finial cost on the basketball court? D. Heiser, we still have to seal it yet. O'Connell, what is the new street alley on West Oak Street what is the name of this alley? There is a sign

there do not block Alley what is the alley. C. Marquardt, we put a sign down there to stop people from blocking the alley. D. Heiser, that was a recommendation from Frank Zangari because you can only get one vehicle thru there and people parking there you would never get the fire truck out. Rick I believe it was just a fire lane I think the borough does not own that.

Barber Tacker, I live at 315 A street about one year ago I requested a handicap parking place and just recently I had the lines painted for parking which allowed me 15feet. I do have a mini cooper which is small. I have ran into the problem where if somebody parks in front or behind me I am unable to get out or open the back of my vehicle to take out groceries and things like that. I am requesting to receive the same space for handicap parking like all the other handicap parking in this town. D. Heiser, when this came about through from social media. There are no size requirements or guidelines for handicap spaces on the borough street per ADA when I called. If it was a parking lot they have guidelines it is 20 feet wide 5 foot on each side clearance if there would be trees. The length is a minimum of 18 feet for a full size car or van and 15 feet for a compact car. D. Heiser, I understand what you are asking but, what we need to do is as a council is look at every single application in the borough. Then when we renew them look them over I don't believe everybody needs. Also we are not required to put in right in front of your home it can be across the street. B. Tacker, but you already approved the lines in front of my house I'm only asking for my application and the ADA does not have guidelines for a small medium or van when it comes to length. D. Heiser, they absolutely do. Tacker, they do not and I can give you the name of the person from ADA that called me back today. D. Heiser, your right the public street they do not. Public parking lot they do. They have no guidelines on a public street. Tacker, the ordinances are state ran and I have not seen any ordinance from Girardville that says my space should be 15 feet because I own a small vehicle. D. Heiser, we as a council could not give you any. Tacker, I'm saying you did. D. Heiser, I would have to look into that if it is in our ordinances size 20 feet we will correct that. Tacker, I want to see a copy. D. Heiser, so would I and I would drop a copy at your home. Tacker, I believe I deserve to see that Marquardt, I know their is other municipalities that I talked to and they just put a sign up, the handicap parking and they don't put any blue lines and they don't put any handicap insignias on the road. We do that and the handicap parking spot is the length of the front of their house right off the bat Ashland Borough does that. Their saying there is nothing set unless you have it in ordinance that says it is that amount in footage there is no guidelines that you have to make it. Tacker, I would like to know what guidelines that you use for other people who were giving handicap parking places and why the guidelines are different for me specifically. Marquardt, I agree and that's why Danny said I want to go and review all the handicap spots and they could all change. Tacker, I feel I'm being discriminated against because I have a small vehicle. Marquardt, sure you are sure I agree with you Barb. Heiser, I agree to I'm not arguing against it. Jeff Dunkel, I think it's sickening that you sit here and say to her we don't have to give you one at all. Heiser, I didn't say her I mean anybody. Dunkel, I understand that. Heiser, it wasn't sickening I'm saying we are not required by law. Dunkel, I'm saying to sit there and say we don't have to give you any I mean she has the proper paper work it was voted on and approved. If she would trade in her car and get a different car it would be bigger than the spot given and the question I have to council is when you award a spot to someone that has the paperwork is that spot solely for that person? Marquardt, no it's open to anybody that has a placard or plate. Dunkel, then why would that spot be different than any other in the borough? Marquardt, exactly. Heiser, you are correct we are not required to give any certain length we're not. Dunkel, no my question is why is that any different than any other one because she's not in titled there's no sign saying that's just her

spot. Heiser, your right if a van wanted to park there it's not big enough I get that. Marquardt, I can honestly ask Marybeth and Rob their former Councilmen I don't know where the twenty feet came from. We don't have anything in here that I can find in the borough records in ordinance or anything where we got the twenty feet. Now there was a thing out in the garage I don't know where that came from and it had twenty feet I don't know who put that up I don't know where that came from but that's what we were going off of the twenty feet until all this came up with Barbra over the parking spot which is a neighbor issue to begin with up there and then Danny checked into it with ADA, Joe checked into it through the state and federal government and this is where we're at now. I think we need to either set the guidelines or we don't set the guidelines but apparently the way it stems from what these guys investigated we can set any size any amount so we're really not discriminating you if that's the rules because if they want to give you fifteen feet Barbra they can if they want to give you twenty or they give you eighteen. Danny said they can give you a motorcycle is you have a motorcycle but it doesn't have to be full length. Heiser, Charlie to make this simple and short she's 100% right if you're looking at it that way the way everyone here is looking at it. If every other spot in this town is twenty feet

(Heiser) I make a motion for tomorrow to paint the blue lines black and put a foot ½ each way and then we the street committee revaluate every spot in this town then adjust them all accordingly. Soucheck, we want to make sure that the letter goes out it's not just to pay the renewal fee come new year you'll have to bring the paperwork and they will all review it that way because there is people that live in that house that may have been deceased or moved on so there all going to be reevaluated. Heiser, also keep in mind that starts a war on that street with parking that's not Council's problem. Soucheck, and we should not be held responsible for that to come back at us.

Heiser, Charlie can you make sure someone seconds the motion. A. Soucheck, I seconded the motion. Heiser, it's just the fairness let's be fair to the lady and give her what everybody else has and if we adjust it in the future we'll adjust people accordingly. Marquardt, what I was trying to say in the beginning of it all if everybody has twenty feet give her twenty feet but you guys are going to review them all and if they all change they all change but what Chris is say here is maybe there is a decision here that we should sit down as a Council and make a set guidelines. Heiser, and there will be some changes that lose them all together because there are some that over the years just kept them and they do not really need them anymore. Marquardt, exactly so I think that the street committee along with the solicitor and whomever self is involved with it we need to come up with a set of guidelines if that is what we decide to do and set the standards of what we are going to give out if we do give out handicap parking spots. Labie, overall how many handicap parking spot we have in our borough? Marquardt, yeah we have them all listed and the renewals. I'll tell you another thing Joe checked on the renewals and all it's a funny thing because every year they get renewed for five dollars in the ordinance it's fifteen. Heiser, and also in the ordinance it does state if you have off street parking on your property you shouldn't have to have it. Marquardt, yes it does say in the ordinance also if you have off street parking you can be denied a handicap parking spot. Soucheck, so in December we are going to send out a letter. Kessler, if your ablator that does not entitled you to a handicap spot. As a matter of fact we don't have to give you a spot if you can walk. So if you can walk down from your home to Katherine's restaurant or wherever we don't have to give you a handicap spot. Tacker, so how would that go legally for somebody who is parked on the handicap spot in front of my house if they can walk and they have a handicap placard? Riedlinger, well once the space has been granted anybody with a placard can park in it. I think what Joe was saying is that they don't have to work spot it in the first place. Tacker, my problem is going to be different because of the neighbor issue. Soucheck, I know there was an issue with cats I talked to Joe Chiarette who we talked to Barbra Umlof down at the SPCA they will not take the cats if we take them there but they will spayed and neuter them for \$25 apiece and we have to rerelease them. Marquardt, I also received a thing that's no nonsense neutering Jimmy Petusky gave me this it's a clinic in Mahanoy City located at 47 S. Main Street there is a phone number is his going to get cards drop them off here. You can get your cat spayed or neutered or cats that you caught like Jim he was getting them and taking them to be neutered up there. It's \$20.00 so this is the paper he handed me today. Well its \$20 until end of September then it goes up to \$35. Marquardt, you can also take your other animals there to. You can take one feral cat as a walk in any more you must schedule an appointment they do have a website. Soucheck, the SPCA is not willing to come an catch them and there is just too many they will not keep them they have over three hundred cats but anybody who is willing to trap them and take them there and tell them where you're from and why your there. I do believe they have traps and I do know someone who has traps. Soucheck, I personally have a problem I mean I know there is five other buildings, I know there is at least fifteen cats the gentlemen behind me feeds the cats and I counted thirteen on his back porch the other night. My flowers are dead, my dogs get fleas, and my dogs are inside dogs. It's a problem which I think the community has to address. That if you are feeding the cats you need to be held responsible because technically you're not allowed to have more than four animals and if your feeding fifteen feral cats and your housing them because the guy behind me on his back porch has a house made for these cats as far as I'm concern these are his cats. He's feeding them and housing them as a community we have to do something about that. Marquardt, I agree.

Joe Catizone, on the corner of John and Main there was a condemned property that is no longer condemned what steps where taking to make that no longer condemned and where was the building permit for that property? J. Wilson, it was condemned because it had reissue. J. Catizone, no not because of structural? Wilson, correct. D. Heiser, so the owner and the person who is working on it both have been cited this week. J. Catizone, fantastic. Kudos also to the Borough Council for taking a hard stance on blight as of last month and reporting all of the properties ticketed very good job we all appreciate that. Catizone, Charlie stood here and gave a very good speech about getting part value and falling through very good job.

Catizone, next question what is the significance of the red tags is that their first warning or is that their citation? R. Miller, that is a ticket under quality of life it is a 25 dollar ticket, seconded offense is \$50. Third offense is \$100.00 then they would get a citation. D. Heiser, then it goes to the magistrate. Marquardt, we had a property down on main street we were notified of, actually Rick, Jeff, and Frankie Zangari went down there and informed the people they can't move in there. They can bring their stuff in. They listed all the code violations I was told by these guys including Frank this was the first time in history within 48hrs everyone of the code violations were corrected because they went down and re-inspected it. Is that correct Jeff? J. Wilson, they were good. Marquardt, there was a landlord that bought the building and is renting it out is that correct? Wilson, it was empty for quite a while 309 W. Main. I was told that somebody was moving in there and I went down there and told them you can't move in here until it is inspected. It took the land owner three days to get up here from NY and he did everything we requested within two days which I thought was great. They are living there now and it's in pretty good shape.

J. Catizone, 44 West Main right across from my house the building is still for rent so we discussed it last meeting that there's going to be an inspection in there before any residents come

in. Heiser, I followed up on that with the person you said it was. I suggested to try and change the Ordinance 74 for rent sign either goes on the building or a ad goes in the paper that you're not up to code and could be cited. Chris says the way our Ordinance is written right now that has a for sale or rent sign on it according to our Ordinance we can demand to render inspection. J. Catizon, I kind of did my own independent research called the guy and he is willing to walk me through the building. Heiser, alright but there's nothing illegal until it's occupied. Catizone, ok but should people be going in and out of there just wily nily because this guys building isn't going to be up to code for a few months. Riedlinger, to say there is nothing illegal until it's occupied maybe not if you have the right to do an inspection you go and see problems inside it, it could be in violation of the property maintenance code. Heiser, we can demand inspection once the rent sign goes up. Marquardt, are the people going in just working on it or look at it to rent? Catizone, that's what I been wondering so I called he said he'd show it. Soucheck, so it's not up to code what you're saying people shouldn't be in and out of it. Catizone, it shouldn't be allowed to advertise it. Soucheck, it shouldn't be up for rent. Catizone, she shouldn't be allowed to take people through it for rent. Soucheck, if we go down there he should be cited and made to take the sign down. Riedlinger, even if there's nothing in the inspection ordinance do the inspection see other problems you can cite him under the maintenance code. Heiser, it doesn't have to be occupied to be under violation of the code. Riedlinger, any structure it just has to do with the structure not wither it's occupied or not. J. Wilson, under the maintenance code it's just falling down. Riedlinger, so the rental ordinance is what gives you the right to do the inspection, the mine maintenance code gives you ammunition to cite them if there is violations and if they go ahead to rent them with those violations you go back to the inspection ordinance to cite them for occupying them. Heiser, if someone moves in the landlord gets fined three hundred dollars a day and its zero tolerance. Marquardt, Jeff are you going to cite these guys now? Wilson, yeah I haven't been down there to physically see if the roof is leaking, walls falling in, I'm not allowed to walk into a property without permission. I can look at the outside if the outside is falling down. Riedlinger, you may be able to in act the ordinance that gives you the right to inspect the property that is for rent. You can't just in act a ordinance to go right in side in general, one for rent you can. Dougherty, that rent sign as been out there for months get creative and pro active. You're reacting to everything we're saying. Talk to Pottsville and get organized act together. Marquardt, did code enforcement and quality of life people go look at 149 W. Main Street on your inspections? Wilson, Miller, yes. Wilson, we had cited him a year ago. He went down and covered up some of the stuff we asked him to do. Marquardt, ok so he didn't cover up everything. Wilson, obviously not. Marquardt, so we can site him now? Wilson, yeah. Marquardt, cite him. Dougherty, that's why this town has that reputation you know where he is. He's not the worst one so we're not going to worry about it. O'Connell recently there was a few properties sold on eBay 2 on line St, one on Preston Ave that porch is falling down. What's the plan of action? Heiser, the new owner will be cited they are being sold as junk. O'Connell, come on start citing them there it is wide open. Miller, Schuylkill Properties was cited through the magistrate 25-23 I think on Line Street. We went to the hiring and the guy came in with his lawyer they said he didn't own it he was an investor and they let him go. Marquardt, check on all these ones that were wrote up on here and find out where we stand with citations and follow ups. D. O'Connell the properties up on line Street they got to come down so what are you going to do about it cite this guy and say look at it buddy it's got to come down but you can't fix them. So what is he going to do jerk us around? Heiser, the only way we can get those houses down is fine the guy for public nuisance. D. O'Connell, there is no way those houses are livable and this guy

is going to jack us around and it's going to be the same thing next month in here. Heiser, let them either continue to pay fines or tear down building that's what Shamokin is doing and it's working really well. Kandi Cope, through social media ex council members I believe are putting down on social media, putting down the police, council, and neighbors, business's. If you want to get Girardville together work together. What is it you're calling people scum bags, stores section 8, Balky's been here many years that has a borough garbage can outside the store that is for the community. I'm saying their sitting here bragging clapping hands and tonight you guys will be nothing but a piece of crap. Why do we put the Borough down. Take the damn Girardville Gazette down. E. Burns, Mike Manbeck started something he is going out on his own and cutting a lot of properties and we don't care. This has nothing to do with the Borough but anyone that wants to join this seven O'clock Monday be over here bring weed wacker's and lawn mowers. I don't care we are starting it because waiting for banks could take months. Bags, Mr. Miller you said 23-25 Line the owner was in the magistrate office why was that thrown out? Miller, wasn't the owner was investor LLC. Heiser, they are trying to change the law that LLC someone will be responsible and won't be so well protected.

## PUBLIC COMMENT

Dan O'Connell, did anyone look at 508-510 E. Mahanoy Ave? D. Heiser, they are on the list Michelle O'Connell told me about that. D. O'Connell there is actually a tree growing across it and you can't see. D. Heiser, I'll go up tomorrow morning I'm off. Marquardt, I don't know if J. Wilson (Code Enforcement) was up because he's not here but if we can get a report from Jeff we might be able to see if he got anywhere with it maybe you guys could contact him in the morning and follow threw wherever Jeff was at.

D. O'Connell is the summer basketball league over and who is responsible for the porta potty? R. Miller, I already told them about it they were called. I called the guy running the league about six times. I called the porta potty company about it twice. D. O'Connell, well maybe you shouldn't have the league come here next year. There are kids that would be over there. We're good enough to let them have the league here. R. Miller, that's not their fault it's the porta potty company. D. O'Connell, it should have been moved right after the league was over instead of it sitting there like that. Marquardt, Ed is going to have the police officer call the porta potty company. We been asking them and they haven't come and the league.

Edna Labie, how about 343, 345 W. Mahanoy Ave when you come up the high road those two properties there's all that junk in the front. I thought no one was living in it but, I saw a lady today out on the porch talking on a cell phone. So I don't know if anybody is living in them but if you come up the high road and your coming into Girardville and it hits you. That's in

Girardville Borough yet it's not in Butler Township. A. Soucheck is that were Kerry Long lives? Labie, I don't know who it is. E. Burns, yes that's who she is talking about. D. Heiser, ok I know where that is. Labie, you know where they are I mean there's been a lot of junk on those properties. I don't know if both of those are occupied or not or if they are at the point they should be condemned. A. Soucheck, that's where Kerry Long is, where the roof is caving in and it's being held up by a board.

Tom Clark, last week the district magistrate held the blight meeting again did anyone go? Or doesn't anyone give a shit? D. Heiser, Jeff was scheduled to go but that was when his accident happened and he didn't make it. Clark, how come Borough Council isn't going? D. Heiser, they were scheduled to go but Jeff got hurt that day. I couldn't go because I had work.

T. Clark, the organizations in town has been going to cut grass and all is the borough following up and fining these people? E. Burns, yes we are. T. Clark, Thank you that's incredible. E. Burns, we go out their fined and we have certified mail returned to us. Sunday afternoon we're going after a guy verbally but no worry there will be a ticket.

T. Clark, did anybody try to get money to tear down Churby's since it clasped in the creek? D. Heiser, there's a process you have to go through. You have to get ownership of the building first we just can't tear anything down. We are trying to get ownership of it but we have to wait until it goes into judicial sale. Once we get ownership of it then we can look for money to tear it down. I understand everyone else in this town is about the blight to. It's more expensive sometimes to purchase the properties for to go about purchasing the properties than it is to tear them down. It's not just Girardville. It's a process it takes time. T. Clark, you got a house that is falling down and the house on the main street fell down within a month it was gone. Now you got a house falling in the creek for over two years. D. Heiser, I don't know how they did that on the main Street. I talked to Chris the past two weeks ago and it's a process you have to go through to inquire a private property to tear it down.

Tom Clark, last month I asked how much it is to tear down a house did anyone come up with it? E. Burns, we are working on it. D. Heiser, a house sitting by itself might be four thousand; a house that sits between two other properties might be twenty thousand. T. Clark, tell us your share for the house on the house Avenue. The last house torn down was on the Avenue. D. Heiser, six thousand. T. Clark, so you have five thousand on the budget and the last one cost six. C. Riedlinger, I can't give you an exact answer to your question about the cost. I can give you an idea of complexity and the potential cost for putting yourself in the position to be able to tear down a structure. As Danny said the first thing you have to do is put yourself in the position to have the legal authority to tear down a house. That could be done by actually purchasing a house at a judicial sale becoming the owner of it or it could be done through a conservator ship under the state laws that allow municipalities to get permission from the judges at the court house to tear down a house. That's what we did with the property next to Tony's Lunch on Main Street. We got a judge to give us a conservator ship and that property was torn down in conjunction with Michelle and Gary Bender at the courthouse and their program. They funded the vast majority of that demolition. Just to give you an idea of, if you're going the conservative ship route. You're going to get conservative ship over that property which will allow you then to demolish it. First thing you have to do is a title search, get a conservative ship, you got to figure out who the potential lean holder is, the actually lean holders are on the property and ideally there aren't mortgages and things like that owed on the property. Usually it's just municipal leans from GAMA or similar entities like that. You then would have to file a petition with the Courthouse of course this is something I would draft. Even before the petition someone from

ENTECH Engineering or someone who is able to come to the court hearing to testify that the property is a dangerous structure, that's likely to collapse or something like that. They'll have to go out to do an examination of the property to reach that conclusion and come to court and testify. I know it seems obvious a house that is falling into the creek is going to be something that is collapsing but in a court room you have to prove to a judge with actual evidence that the house is a dangerous structure. The way that is done is to get someone like from ENTECH who can testify as an expert on the structural sound as a property to do an examination and be able to come to court and testify for you. So you're paying Entech the people to go out to do examinations of the house, you're paying me to draft the petitions, part of drafting the petitions also is notifying all the potential lean holders of the action because any of those lean holds could come and object to a conservative ship. Because they are losing the property sort of speak to that they have their leans on. Which I said ideally there are mortgages and things like that on the property because if you are dealing with property with mortgages the bank may come and object the conservative ship you may not even get it. Of course if there's some individual that has some lean on the property that could really set this whole thing back significantly and increase the cost. If Joe Smith could be one of these people that lives in Nevada has a lean on that property and you have to notify Joe Smith of your conservative petition. You may have to find Joe Smith to notify him of the conservative ship petition. Eventually, hopefully a judge has a hearing on the conservative ship petition. Now you're going to pay someone from Entech to come to court and spend half a day in court to testify before a judge about the structural sound of the property. You would be paying me to go to court as well. Then ideally you get the conservative ship approved by a judge and this goes relatively smoothly you are probably talking about at this point five thousand dollars in just fee in the engineering firm and myself. Now the demolition it's self after you get the conservative ship, which is the permission to search out and tear down the property. If the demolition is likely to cost an excess of whatever the bidding limit is nineteen thousand something right now. I think its nineteen thousand one hundred but I could be wrong about that exact figure. You're going to have to bid the property (job) out. The borough can't just hire someone to demolish the property they got to bid it. So you're going to probably be paying someone from Entech Engineering a couple thousand dollars to draw up specks for the bidding. Then ultimately you'll have the bidding and somebody will come in with whatever the project is going to cost. C. Riedlinger, I know in the past the borough when we done things with Gary Bender and Michelle's program at the county level its cost us several thousand dollars and that was just a twenty five percent share. If we had to pay the full 100% share because this isn't something the county is taking part with us, it's very reasonable to assume that the demolition costs are going to be in the twenty thousands of dollars. This not a quick easy process and is certainly not an inexpensive process but I just going to give an estimate and this is just an average run of the mill case. There are some cases that could be more could be less. There could be corky circumstances that a rise in any case but I think it is reason to assume that if the borough was going to fund 100% of the demolition and they had to go through this entire process to get the permission to demolish the property in the first place it's not unreasonable to think that the entire project is going to cost in the neighborhood of twenty-five thousand dollars. I can't give you an exact figure but that's a good bet. D. Heiser, it's expensive we are trying to find these people and fine them through the building maintenance code and hopefully irritate them enough that it forces them to do something about it themselves. Dougherty, you can go after their personal assists now years ago you couldn't now you can.

M. O'Connell, was 44 Main Street looked at? C. Marquardt, I believe Jeff looked at that also. O'Connell, garbage piled up. Marquardt, which was brought up last meeting he went down the next day.

Bernie Adams, my building where pigeons were getting in and both Frank and Jeff seen the repairs. I had two properties on 150-152 Main St. that are inspected and rented out. Marquardt, the old stack building what are your intensions? Adams, tear it down, don't have a time frame yet. D. Heiser, the building across the street the roof is in bad shape. The garage behind is a bird bath the pigeons are going in the other house. Marquardt, you to give a proposal on the properties you buy. You will be cited if you don't take care of your properties. D. Heiser, building needs to be safe or you will be fined. If the house is not in good shape in the next month you will get a citation in the mail or on building. Adams, everything Jeff and Frank told me was fixed and it's fine. Marquardt, check with Jeff and Frank on that property and see what they said. Marquardt, 139 fix to rent it? Adams, yes.

R. Krick, The treasurer's report last month there was a check cut to the Chief of police \$250 General fund what was that? E. Burns, he sold to the borough a computer. Krick, should have been at a public meeting voted on or brought up. D. Heiser, we did get the call about it we're all aware of it. Krick, I would make a point to know that in Pennsylvania we have a right to know that I mean sunshine law. You should have to come back in here and make a public vote and let it be known who you are buying it off of. How much it costs. Even negotiations and discussions concerning anything should be made in public before the vote. How much was the computer anyway? J. Kessler, \$700 came with two surge protectors. D. Heiser, it's not just a home computer you need more of a hard drive with quick books and more information stored you need a bigger hard drive.

Wade, what you get with Ann Murphy house? E. Burns, he was cited we are waiting hiring. Marquardt, he was cited and once the magistrate get's it she'll tell him exactly what to do. E. Burns, at this point we can't forcefully put him out of there. C. Riedlinger, if you condemned a building which prohibits the occupants from living there, the mayor is right you can't physically remove them all you can do is cite them.

E. Dougherty, Charlie the bills here, is this the list of bills from last month supposed to be this month? The bills from August? C. Marquardt, I have to get with Candice when she comes back because she has duplicates here. I don't know what happened here if it was a computer error or what I will get this straightened out before next meeting. I don't understand there are ones from last month here. I have to wait until Candice comes back to find out.

### **COMMITTEE REPORTS**

Street: \*Ashes will be picked up starting in November on Mondays and Fridays. Ashes must be covered if it is raining. \*Curb side recycling ends Dec 29<sup>th</sup> weather permitting and resume last Tuesdays starting April 26<sup>th</sup> 2016. \*Emergency Snow removal 3 or more inches of snow the following streets will be in effect no parking on Lower Railroad St and Preston Ave on day of the storm. No parking on day one of the storm even sides of streets will be Seconded, B, A, and Ogden Street. On day two no parking odd side of Streets Seconded, B, A, and Ogden Street. Until completion these roads must be kept open. Vehicles that are not removed per stated will be cited. Anyone caught throwing snow into streets after being plowed will be cited. Private contractors need to remove the snow piles they make or will be cited.

Fall Clean Up: Borough had tremendous amount of TV's, computers, and the trailers filled up quick. Due to trailers in Philadelphia they could not get out with the Pope visiting which caused high volume of traffic and streets shut down. Another contractor had to come in. Marquardt has been in contact with the County. One man came to pull a trailer out and was not the guy for that trailer so he put it down at the end of town. The County is aware of it and is trying to get a hold of that trailer company. The pallets and cardboards came with their own trailer last time. This time the trailers did not come with pallets or cardboards and this year they had three different companies one for the trailers, one for pallets, and one for cardboards. The Clean up was a good success and Marquardt thanks the Municipalities participated and helped us out and everyone else. Hopefully we can do it again next year and get the snags out.

Finance: Budget will be in November meeting.

**School Building:** The doors were painted by Jim Evans and Ray Wayne Jar who was providing community service. The center lights weren't working waiting for the electrician.

Solicitor: September 22<sup>nd</sup> Riedlinger and Marquardt attended hearings before the Schuylkill County Tax Assessment Appeal Board regarding two parcels of land. Parcel #45-08-0090 and #45-09-0001 both are owned by the Diocese of Allentown. They were previously used as Church properties and they are currently not being used for that purpose. Riedlinger and Marquardt went to the hearing with the purpose to have their tax exemptions removed. The lawyer representing the Diocese stipulated that they are no longer being used for church purposes and as such their right to an exemption is no longer valid. We have not yet got a written decision from the appeal board but because the other lawyer stipulated they are no longer entitled to the exemption. Riedlinger feels the decision will be in the borough's favor. Diocese may file an appeal to challenge the valuation in the property. The valuation is currently set by the 1996 County Wide revaluation. They claim the property is higher. The value of the property on the tax roll is higher than it really is. They will probably have an appraisal done on the property and probably file an

appeal to have the valuation of the property change more in line to whatever their appraisal says. The Borough at the time will make the decision whether or not they're going to have an appraisal of their own done to challenge such an appeal done by the Diocese. Marquardt, one parcel is the vacant lot old school and the other is The Rectory of Church. M. Dougherty asked what about St. Vincent's? Marquardt, I was down with Mr. Reilly and the lawyer. It looks like Father Bambrick will be coming out to St. Vincent's to be stationed here at the rectory. That's what he said it's not a commitment. Dougherty, the bulletin had said it was going to sale. Marquardt, it's interesting because we questioned that down there and the lawyer quickly jumped on me saying I couldn't bring up the rectory at St. Vincent's at this particular appeal because I didn't have it on the docket. I questioned it as to what was the status of it. Mr. Reilly said looks like Father Bambrick will be taking up residency in that rectory. Marquardt, if he doesn't and it is sitting empty next time around we try to get it appealed.

Tom Clarke- Medical Center? Marquardt, I will definitely have an answer next Council Meeting. I believe I am serving on the board in place of Joe Chiaretti the Council member before.

Burns, the CEO for Geisinger resigned and they needed to appoint another CEO and that's what happened.

Annetta Whitecavage-did Danny Heiser give any reason for his resignation for this time? Marquardt, I read off exactly what he had on the letter. That was it.

Wade Richards- Ann Murphy property the guy that was supposed to be kicked out. J. Wilson I cited the landlord. They will be recited both landlord and tenant.

Dan O'Connell- thanked the two seniors who ran the car wash for the Ambulance group for the radios.

- D. O'Connell-Did anyone look at 508-510 E Mahanoy Ave? The roof is coming down and has asbestos. J. Wilson, I was up there and I don't know if it's on the repository list or not. O'Connell it is. Wilson, if it is there's not a whole lot we can do about it. We can try to cite the original owner. Marquardt, Jeff can you Rick and Frank look at that? Wilson, sure.
- D. O'Connell, did anyone attend the Blight meeting at the court house? Marquardt, I know I did not. D. O'Connell, my point is the guy from Ashland he went and he said what they did. This guy bought a house in Ashland for 650 I think I'm not sure. Anyway they have been fining him and now the fine has gone up about 600 dollars. I mean this guy is paying the fine but that's what I think we have to start doing.
- M. O'Connell- the letter from Commissioners office what is the address for that parcel? Marquardt, it says the parcel #45-7-0117 address is 0 E. Main street owner was Walter Shall and the bidder on property was Ed Burns it was next to Ed's price was \$200.00.
- M. O'Connell- did you guys look into getting the properties over on Ogden? Any temps made to get it? Marquardt, no reason we didn't know it we would have the funding available to put up our share to tear those down, we don't believe anyone is going to purchase them. We still believe we can go in and get the properties. There is concern when we tear the two down what to do with the third one because there are people in it.
- M. O'Connell- what about the one on Ogden Street? (136 and 138 Ogden Street)
  Marquardt, the lady lives in England (Sarah Kinsett and Raymond Wolfgang) I believe the other

owner lives down the Valley. J. Wilson, it's one house two separate properties two addresses. Every time I send a letter I get nothing back from anyone. It is on repository and has been for years. M. O'Connell, that is the cheapest on the list. Marquardt, what would it cost to tear Whitley's down? Michelle O'Connell, right now we are getting estimates in for houses standing alone. We did one in Foster Township for \$7,500 and we did one in Frailey for \$8,500.00. I had that list made at one time and said it was the cheapest for demolition. Marquardt, what we need to do is get a price on what it would cost to tear that one and what it would cost to tear Churby's down and see what the figures come in at and what our 25% would be.

M. O'Connell, do we have a total cost for basketball courts repairs? Marquardt, I don't have the exact cost here. E. Burns, it was 600 and sum dollars for the black top and sealer was 56. M. O'Connell, so it was 250 to repair the sealer. Marquardt, yes. O'Connell, is there a fundraiser for the other repairs. Lights for the gym need to be replaced. M. O'Connell, here is my argument why do we have to have fundraisers for nonsense repairs that don't benefit the town. Ann and Jenna had a fundraiser TNR to help control the cat population then the Ambulance fundraiser. Why can't we have a fundraiser like Minersville has and put up flags the Main Street for Veteran's or something? Instead of having fundraisers for mistakes. Benefit the town. E. Burns, Crime Watch has the fundraisers for police department. O'Connell, yeah and that's benefit. E. Burns, fundraisers work if you get enough of people to help. O'Connell, but for mistakes. Dougherty, well quite honestly fundraisers, if you budget properly and spent money properly you shouldn't be coming back to the public asking for more money besides the tax funds.

Patricia, land bank? Marquardt, Danny Rick Joe attended those meetings. R. Miller, the hold is due to the School District. Marquardt, the school district is trying to conduct their own I believe. Miller, that's the understanding I got when we attended the meeting. Patricia, would it benefit the borough? A. Soucheck, if North Schuylkill doesn't get in it Girardville Borough won't get anything out of it. If North Schuylkill does join and they didn't include us it would be social suicide on their part to exclude us. The Borough goes in and they are not it wouldn't benefit us it would be a waste of our money.

J. Catizone, Code enforcement report is that this months and last months? Miller, no. Sandy Wilson, I was here last week because Jeff could not make it. Tuesday before the meeting I went in personally and handed in envelope right. What happen Thursday I went to the meeting he didn't make it. They said Code officers report there isn't any. Miller, I didn't have it when I came in here. S. Wilson, why didn't you have it I came up Tuesday Joe, Annie, Mike where there when I came in as my witness. Miller, I didn't have it. S. Wilson, why didn't you, I did hand it in Tuesday last month and you were supposed to make a copy. You make it look like he isn't doing anything. J. Catizone, can I just get last month report is there numbers from last month. S. Wilson, everybody wants to be the boss up there. You got rid of Danny who else is going to go. E. Burns, we did not get rid of anyone they quit. D. O'Connell, because nobody was working with them. That's why they quit.

Rob Krick, last month or month before Miller said there was a hiring concerning a building on Line St. I followed up on it I found out the citation was withdrawn. Miller, because they sold the property. Krick, it was withdrawn 11/14/14 that was a year ago. Miller, no it wasn't even written a year ago. Krick, it was written 8/12/14. Miller, I'll read it but I'm telling ya. I wouldn't withdrawn nothing. Krick, it was withdrawn last year. Miller, I don't know how it was withdrawn last year I'm going to have to find out. Krick, I looked for any other citation issued to this guy. Dougherty, Ashland is going after them home owner and new owner not only civilly

but criminally. Cite them put some pressure on these people oh my god. Marquardt, are we going to cite these people? Miller, yeah I'll talk to Frank he was the one who talked to her. Dougherty, Frank is doing his civic duty here it's you guys that should be doing it. Frankie is just helping. Marquardt, will you guys cite the ones on Line St. Can you cite the owner of that property? Jeff Wilson, yes we can. Marquardt, will you please do that. J. Wilson, sure. Marquardt, Jeff will cite that person up there. Also 508-510 Cite those maybe need Chris's help let see what we can do about them.

Dave, I represent the Mahanoy Creek Water Association and on their behalf they want use of the Borough hall October 14, 2015 @ 7 O'clock there is a public meeting and is in reference to the property the water shed recently purchased directly across from the Borough Hall 28 Acre Parcel the nature trail is currently under construction and it will shed some light on that at the public meeting and also the future plans we would like to see take place on that parcel. The public is invited and again we thank you for the use of the building and also for storing some of our construction equipment while we are in the process. Marquardt, anything we can do let us know.

Janet Zangari, you mention about snow removal with PennDot on the main street, we had a lot of trouble last year with a car parked in front of our home never once was it moved all winter long with snow coming down. As soon as the snow melted we got accused of breaking a light with moving our snow. Maybe you should do with PennDot see about doing something with that Avenue up there. Because we own three properties we don't have one property to put our snow not a one. A. Soucheck, Charlie it is that entire block up there. Marquardt, it was also discussed with the one from Main St that section was talked about. J. Zangari, we need more than talk. Marquardt, the problem becomes over there again the cooperation of the neighbors the cooperation of everybody. So when you move cars those people will have to go to the back then when you do the other side those people would have to come over or go to the back side so they could do the other side. There's no way you can move both sets of cars on Mahanoy Ave in one shot because there is nowhere to go with them. There's probably going to be complications on the Main St because we just don't have the room. J. Zangari, alright we had one spot with the snow that's in front of Kelly's house and we got in trouble because the snow was blocking his access for his coal delivery. Ron, but we had a car sitting there for three months that didn't move and snow piled on it 25ft high. Marquardt, did anybody call and report it was the car legal? Janet, yes and the car was not legal. We did report it nothing was done. Marquardt, talked to whom? Ron Zangari, we talked to Mel about it. Marquardt, so there were no citations issued. Ron, we were told by Mel you can't have snow anywhere you want it. The car was sitting across the street for three months not being moved. Marquardt, was the owner of the property a neighbor of yours up there? The problem is their over there in Labie's old place and they have three cars and they park them anywhere they like some of them aren't inspected some aren't insured and whatever else they just park there. Marquardt, are there ones over there now just like that? Ron, yes. A. Soucheck, and there is nowhere to go across the street with the snow they have no place to go. Janet, they say no parking across the street on all those buildings where you can't get on the side walk and he does park his one car over there to. Marquardt, will you please give that information to the Mayor so he can follow through with the Police Officer. Janet, well why wasn't that my husband who is pretty much unable to shovel snow had to get out in the snow because they decided all of a sudden it was blocking his coal thing. Marquardt, who decided? Burns, the Kelly's. Marquardt, who made you move it. Janet, the Police Officer. Marquardt, so see it was a situation where it never came before Council we had no idea what happened. Marquardt, so you

put your pile of snow on Kelly's access to get Coal into his house. Janet, no not at all he would have got his truck in front of the snow pile and put his shoot right to his hole, but he went and yelling we got camera's we know you put the snow there. So something has to be done with that snow.

Annetta, when are they going to start filling in potholes. Marquardt, as soon as they can. Annetta, and are they going to do all of the town? Marquardt, whatever the funding we have to do that's what we're going to do. We will take the best approach and do the best we can. Right now they have a couple of other things just got done with the fall clean up, do the courts down there so yes they will be going after potholes when they can. Annetta, remind them I don't live in Butler township, Marquardt, yes. Annetta, like most people think that block down there is still the borough. I was told one time before I don't live in the borough. Which is not true.

They are checking into that with Lisa who is in charge and I have not yet heard back yet what is going to take place there.

Tom Clark, Fines issued for Blight are they the maximum they can issue or can they bump them up? C. Riedlinger, if you are talking about the property maintenance code the Borough doesn't issue the fines. The Borough has to file citation which the correct procedure to leave the fine line blank because the magistrate sets the fine. The fine ranges are \$100 to \$1,000 and I can personally guarantee you the magistrate don't impose the maximum fine unless it's somebody who is back in there many many times. But that is up to the magistrate. The maintenance code has a section in there that says the fine could be as low as \$100 or as much as a \$1,000. If you are talking about the Quality of Life Ordinance I think there are specific fines set for specific violations like a first offense I think is \$25.00, seconded offense is \$50.00 but these of course are for the QOL violations. You're not going to be going after someone with a dilapidated building for a QOL violation that's going to be under the maintenance code. For the QOL there are specific fines for specific number of offense that it is and there set by the ordinance. That's not for a citation that's for tickets being handed out directly by ourselves. T. Clark, Blight cost money is there any way to raise the \$100 minimum? Riedlinger, I know that the case but were going to end up having someone who otherwise house is in immaculate condition but has a crack in their window who has to pay a \$1,000 fine and they you'll see that home owner come in and say how fair is this that every fine is \$1,000.00. I know what you are saying but the reality of the situation is your looking at the most egregious violator but there are people who are not the most egregious violator and if every fine is \$1,000 then everyone is going to be paying the same fine even if their property is just a slight thing wrong with it. T. Clark, Can we raise them up it cost money every time you go to a hearing. C. Riedling, we I don't usually go to those hearing but I know what you're saying I do. The borough Council could vote to amend the ordinance and change the fine section if they wanted to but I want to caution them verbally the same way I'm cautioning the public right now if you have a fine section it would be like if the legislative set, every crime can't be murder, life in prison can't be the punishment for every crime there has to be some allowance for thirty days probation. Otherwise, everyone convicted of the most minor violations is going to face the same penalty as the most egregious violator. Could you change the fines if they wanted to yes they could and if the Council wants me to do it I'll draft it and we will do it. The problem with that is then person who has one minor little thing wrong with their property is going to pay the \$1,000.00 the same as the person whose house is falling over. T. Clark, well right now the person with the house falling down is paying the same as the person with the window crack. C. Riedlinger, all I can tell you is that is why you have to leave it to the discretion of the district justice. You can't devise a one size fits all fine because not all the violations are the same size you just can't do that. T. Clark, can we raise that? C. Riedling, yes you could.
