IF SPACE IS GRANTED, THE FOLLOWING REGULATIONS WILL APPLY:

1. All criteria of Borough Ordinance # 94-4, as enacted or amended, shall apply.
2. An initial fee of \$150.00 Dollars shall be imposed to assist in defraying the cost of processing the application and erecting and maintaining the signs. Such fee will be paid to the Treasurer of the Borough of Girardville to be placed into the general fund. This fee is NOT returnable and in the event of misuse or transfer, the sign shall be removed without notice.
3. It must be understood the fee imposed is for installation and maintenance of the handicapped sign. You are NOT buying a parking space...Any statement by the applicant that this space was "BOUGHT" is cause for immediate removal of the sign.
4. This application will be subject to review and approval or rejection by the Council of the Borough of Girardville.
5. In each subsequent calendar year, the applicant shall pay a Ten (\$10.00) yearly renewal fee which shall be due before the THIRTY-FIRST DAY OF JANUARY....

CRITERIA FOR HANDICAPPED PARKING ZONES

Be it ordained by the Town Council of the Borough of Girardville in lawful session duly assembled as follows:

SECTION 1. Any individual requesting an on street handicapped parking space within the Borough of Girardville shall submit an application to the Borough Council who shall refer it to the Street Committee for recommendation. This application shall be on a form provided by the Secretary. Any individuals who propose to maintain eligibility of existing handicapped parking space beyond December 31, 1995 shall likewise, submit an application to the Council.

SECTION 2. The Council shall review all applications so submitted and shall report decision to the applicant. Anyone aggrieved by the decision of the Council shall have a right of appeal under the Local Agency Act to Borough Council. The Council or its designee shall include in a monthly report at the regular Borough Council Meeting information as to the handicapped parking space permits upon which any action was taken by the Council since the prior months report to the Borough Council.

Council shall review all handicapped parking spaces or areas at least once annually to determine whether or not the individuals so requesting the handicapped parking space or area are still in need of said handicapped parking space.

SECTION 3. The creation of a handicapped parking space shall be as follows:

A. The individuals so requesting the space shall exhibit proof that he has qualified for a handicapped person's licenses plate under the regulations issued by the Pennsylvania Department of Transportation or that he/she already has such a licnese plate or placard.

B. No more than one handicapped parking space can be requested by any one individual within the Borough of Girardville.

C. No more than one handicapped parking space can be requested by any person from any one dwelling unit within the Borough of Girardville.

D. No handicapped parking space shall be provided for the location so requested if there exists a reasonably assessable and practical off-street parking space to serve such location.

E. The individual requesting the handicapped parking space shall, in making application therefor, demonstrate that the individual has a physical impairment which substantially restricts mobility or otherwise requires the use of a wheelchair or crutches. If the person for whom the space is being requested is ambulatory then the application can be denied, within the discretion of the Council considering all the relevant factors enumerated herein are absent.

F. No handicapped parking space shall be created unless it can be demonstrated that the physical condition giving rise to the request is reasonably expected to persist for a period of no less than six (6) consecutive months.

G. In considering an application for handicapped parking space, a report or letter from the applicant's treating physician may be considered but any such report shall not, by itself, be considered conclusive.

H. In the event there is a material improvement in the physical condition of the applicant to the extent that the applicant would no longer qualify under the criteria set forth herein, the handicapped parking space shall be removed.

I. No handicapped parking space designated as provided herein, shall be considered an exclusive parking space to the person making application therefor and said parking spaces shall be available to any vehicle displaying the handicapped plate or placard issued by the Department of Transportation.

SECTION 4. Unless otherwise applied for and approved as set forth above, all existing handicapped parking spaces shall terminate as of January 30, 1995.


All other applications for handicapped parking spaces shall be submitted annually. If the application is approved the applicant, as a condition to the creation of the handicapped parking space by the erection of appropriate signs and the like, shall resubmit the application by January 30th of each year thereafter verifying that the conditions require a continuation of the handicapped parking space.


SECTION 5. This ordinance shall not limit the discretion of the Borough Council to establish handicapped parking areas at other locations where the Borough Council deems appropriate.

SECTION 6. All ordinances or parts of ordinances not in compliance herewith are hereby repealed.

AMENDMENTS TO HANDICAPPED PARKING ORDINANCE

The following are additions to the section indicated -

Section 1. Applications to be reviewed by

Street Committee for recommendations to Council.

Section 3.A. Applicant must have or be eligible for

handicapped license plate B & C. A handicapped parking

space can be requested rather than "shall be designated

for". E. If applicant ambulatory then application

can be denied.

Section 4. Yearly re-application required.

Section 7. Application fee \$25. and renewal fee \$15.

Section 8. Penalties - \$300.00 fine and/or 90 days in jail for false application.

GIRARDVILLE SEWAGE FACILITY ORDINANCE

1. Girardville Area Municipal Authority (GAMA) was

created to handle sewage requirements for Girardville

and Butler Township.

2. Purpose to comply with PA Law.

3. Property owners within 150' of system must connect.

4. Connection mandatory.

5. Hook-up procedures must be followed including

inspection during installation.

6. GAMA shall establish specs for connection.

7. All sewage producing properties must be permitted

and owners must pay the costs.

8. All properties owners are legally required to connect

and pay required fees.

9. GAMA and Borough will notify the public of connection

requirements and deadlines in local newspaper.

10. \$300. fine and or 90 days in prison for each day of

violation for failure to comply.

11. Property owners are required to pay service fees

assessed by GAMA whether or not actual connection.
